## Supply of Fertilizers to Odisha

(a): The details of requirement and availability of fertilizers in Odisha for the last 06 months is enclosed as Annexure- A. The availability has always remained comfortable.
(b) \& (c): As per the information provided by the State Government of Odisha, localized grievances of farmers on shortage of fertilizers is addressed at Block and District level through proper monitoring of supply \& distribution of fertilizers. Further, regular quality control and enforcement activities are carried out for ensuring supply of quality fertilizers to the farmers in the State. Besides, the state fertilizer Cell also coordinates with manufacturers/importers/distributors for distribution of required quantity of fertilizers in accordance with the allocation.
