Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) whether it is true that nearly 20 proposals have received from the Government of Telangana for setting up of working women hostels in the State during the last five years;
- (b) if so, the details of each of the proposal received;
- (c) the details of money sanctioned, approved, released and spent on each of the above proposal to construct working women hostel;
- (d) the allocation made in 2023-24 Budget for the purpose; and
- (e) the details of the steps taken by the Ministry to complete all the working women hostels in the State in a time-bound manner?

**ANSWER**

(a) to (c) Under the newly approved Mission Shakti, Working Women Hostel (WWH) known as Sakhi Niwas is a demand driven Scheme. During the last five years, 16 proposals were received from the State Government of Telangana for setting up of working women hostels. 06 proposals were approved and 10 proposals were not approved on account of incomplete documents. The details of Number of proposals received, amount approved and released are at **Annexure-I**.

(d) For the FY 2023-24, an amount of Rs.71.00 crore has been allocated for Sakhi Niwas Scheme.

(e) The Ministry regularly obtains physical and financial progress from the State in respect of the approved projects under the Sakhi Niwas Scheme. Besides, Ministry continuously monitors the progress of implementation of Schemes through physical and virtual meetings with States/UTs, field visit by the officials of the Ministry and through digital mode and takes appropriate measures and issues advisories to States/UTs from time to time.
