Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the number of food samples analysed, found non-conforming and action taken against the concerned Food Business Operators during each of the last three years, State/UTwise particularly in Karnataka, Chhattisgarh and Maharashtra;
- (b) whether there has been a shortage of manpower and equipment in the State Food Laboratories (SFL) in the country, if so, the details thereof; and
- (c) the corrective measures taken/proposed to be taken by the Government in this regard?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a) to (c): The implementation and enforcement of provisions under Food Safety and Standards (FSS) Act, 2006 primarily lies with the State/UT Governments. However, to address the shortage of manpower and equipment in the State Food Laboratories (SFL), FSSAI is implementing a Central Sector Scheme named "Strengthening of Food Testing System in the Country including provision of Mobile Food Testing Labs (SOFTeL) under which State Food Testing Laboratories (SFTLs) are provided funds for setting up lab with basic lab equipment, installation of high end equipment and establishing microbiology lab. FSSAI has also provided grants to States for National Accreditation Board for Testing and Calibration Laboratories (NABL) accreditation, Certified Reference Materials, Consumables and for hiring contractual manpower. To extend reach of basic testing facilities even in remote areas, FSSAI has provided mobile food testing labs called Food Safety on Wheels (FSWs). FSSAI has released total funds of Rs 404.82 crore under SoFTeL for SFTLs (including FSWs) to the States/UTs till 15.03.2023.

Ministry of Food Processing Industries (MoFPI) has informed it is implementing a scheme namely Food Safety & Quality Assurance Infrastructure under Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) to assist the Setting-up/Up-gradation of Food Testing Laboratories in the country. Under the said scheme 162 Food Testing Laboratories have been assisted by MoFPI till 15.03.2023.

Based on the information received from the states/UTs, state-wise details of various kinds of food samples analyzed, found non-conforming and action taken during last three years is at Annexure-I, Annexure-II and Annexure-III.
