Will the Minister of **CHEMICALS AND FERTILIZERS** be pleased to state:

- (a) whether the Government has details of the product basket of PM Bhartiya Jan Aushadhi Kendras;
- (b) if so, the details thereof;
- (c) the details of the number of drugs, surgical instruments and products like protein powders which are provided through the said scheme in the last nine years to till date, State-wise;
- (d) whether there is a delay in supply of medicines in Andhra Pradesh and Telangana;
- (e) if so, the details thereof;
- (f) whether any individuals/companies have made any requests to the Government to give permission for setting up regional centers in Andhra Pradesh and Telangana; and
- (g) if so, the details thereof along with the details of rejected applications in this regard?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF CHEMICALS & FERTILIZERS (SHRI BHAGWANTH KHUBA)

(a) & (b): The product basket of *Pradhan Mantri Bhartiya Janaushadhi Pariyojana* (PMBJP) comprises of 1,759 medicines and 280 surgical devices as on 28.02.2023. The product basket presently covers all major therapeutic groups such as Cardiovascular, Anti-cancers, Anti-diabetics, Anti-infectives, Anti-allergic, Gastro-intestinal medicines, Nutraceuticals, etc. In addition, various nutraceutical products like Protein Powder, Malt-based Food Supplements, etc. Some AYUSH products like Ayuraksha Kit, Balraksha Kit and Ayush-64 tablet and Chyawanprash as Immunity boosters have also been added in the product basket.

(c): The growth in product basket during the last nine years is as under:

These medicines are available at the Kendars opened all over the country and no statewise details are kept.

- (d) & (e): As informed by the Pharmaceutical and Medical Devices Bureau of India (PMBI), the Implementing Agency of the Scheme, there is no delay in supply of medicines in Andhra Pradesh and Telangana.
- (f) & (g): PMBI had received an application for appointment as distributor in Hyderabad, Telangana in September 2022. However, as PMBI already has a strong network of four warehouses and 36 distributors all corners of the nation, it has decided that there is no need to increase distributorship in the country as of now.
