UPGRADATION OF SAMAGRA SHIKSHA SCHEME TO ALIGN IT WITH NEP 2020

Will the Minister of EDUCATION be pleased to state:

- (a) whether the Government has upgraded the Samagra Shiksha Scheme to align it with National Education Policy 2020;
- (b) if so, the details thereof and the action taken thereon;
- (c) the work done under the Information and Communication Technology (ICT) component of Samagra Shiksha Scheme so far; and
- (d) the work done/achievements under the mentioned scheme especially in rural areas?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SMT. ANNPURNA DEVI)

(a) & (b): The Department of School Education and Literacy is implementing an Integrated Centrally Sponsored Scheme for School Education- Samagra Shiksha since 2018-19. The scheme has now been redesigned and aligned with the recommendations of the National Education Policy, 2020 and continued till 2025-26. It aims to ensure that all children have access to quality education with an equitable and inclusive classroom environment which should take care of their diverse background, multilingual needs, different academic abilities and make them active participants in the learning process.

The major objectives of the Scheme are: (i) Support States and UTs in implementing the recommendations of the National Education Policy 2020 (NEP 2020); (ii) Support States in implementation of Right of Children to Free and Compulsory Education (RTE) Act, 2009; (iii) Focus on Early Childhood Care and Education; (iv) Emphasis on Foundational Literacy and Numeracy; (v) Thrust on Holistic, Integrated, Inclusive and activity based Curriculum and Pedagogy to impart 21st century skills among the students; (vi) Provision of quality education and enhancing learning outcomes of students; (vii) Bridging Social and Gender Gaps in School Education; (viii) Ensuring equity and inclusion at all levels of school education; (ix) Strengthening and up-gradation of State Councils for Educational Research and Training (SCERTs)/State Institutes of Education and District Institutes for Education and Training (DIET) as nodal agency for teacher training; (x) Ensuring safe, secure and conducive learning environment and maintenance of standards in schooling provisions and (xi) Promoting vocational education.

(c): The ICT and Digital Initiatives component of Samagra Shiksha covers Government and Government aided Schools having classes VI to XII as per the following provisions:

A. Budgetary provisions

The non- recurring/recurring grant under 'ICT and Digital Initiatives' for schools is available to the States and UTs for following two options:

Option I: Under this option, schools which have not availed the ICT facility earlier can either opt for ICT or smart classrooms as per their requirement and need. In case of more than 700 enrolments, an additional ICT lab can also be considered.

Option II: Under this option, schools which have already availed the ICT facility earlier can avail smart classrooms/tablets as per the norms of the scheme.

B. Financial provisions

ICT Lab: A non-recurring grant of up to ₹ 6.40 lakh per school and recurring grant of upto ₹ 2.40 lakh per school per annum for a period of 5 years.

Smart Classrooms: The non-recurring grant for Smart Class rooms is of ₹ 2.40 lakh and the recurring grant is ₹ 0.38 lakh. To facilitate online education, a comprehensive initiative called PM eVIDYA has been initiated as part of Atma Nirbhar Bharat Abhiyaan on 17th May, 2020, which unifies all efforts related to digital/online/on-air education to enable multi-mode access to education. The initiative includes:

- DIKSHA (one nation, one digital platform) is the nation's digital infrastructure for providing quality e-content for school education in states/UTs and QR coded Energized Textbooks for all grades are available on it.
- One earmarked Swayam Prabha TV channel per class from 1 to 12 (one class, one channel).
- Extensive use of Radio, Community radio and CBSE Podcast- Shiksha Vani.
- Special e-content for visually and hearing impaired developed on Digitally Accessible Information System (DAISY) and in sign language on NIOS website/ YouTube.
