# GOVERNMENT OF INDIA MINISTRY OF TRIBAL AFFAIRS LOK SABHA UNSTARRED QUESTION NO- 5117 TO BE ANSWERED ON- 03/04/2023

#### HOUSE TO SCHEDULE TRIBES

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) whether the Government have been providing houses to Schedule Tribes section of society in the country;
- (b) if so, the details thereof;
- (c) the number of houses provided to the Scheduled Tribes people State-wise, particularly in Maharashtra under the Pradhan Mantri Awaas Yojana (PMAY) Tribal Sub-Plan during the last five years, yearwise;
- (d) the details of funds allocated, released and utilised for the said purpose during each of the last three years, State-wise;
- (e) the aggregate cost of housing incurred under the PMAY- Tribal Sub-Plan scheme in various States particularly in Odisha during the said period;
- (f) the steps taken by the Government to achieve the construction cost for meeting the target; and
- (g) whether the Government plan a National Scheme of providing houses for homeless tribal families in a phased manner, if so, the details thereof?

### **ANSWER**

MINISTER OF STATE FOR TRIBAL AFFAIRS (SMT. RENUKA SINGH SARUTA)

(a) to (g): Government is implementing a scheme Pradhan Mantri Awaas Yojana – Gramin (PMAY-G) through Ministry of Rural Development (MoRD), for providing financial assistance to the eligible beneficiaries for construction of houses. As informed by MoRD, Under Pradhan Mantri Awaas Yojana-Gramin (PMAY-G), beneficiaries are provided financial Assistance of Rs.1.20 lakh in plain areas and Rs.1.30 lakh in hilly States (including North Eastern States and UTs of Jammu & Kashmir and Ladakh),

difficult areas and Integrated Action Plan (IAP) districts. Additional assistance of Rs.12,000/- is extended for construction of toilets through convergence with Swacch Bharat Mission – Gramin (SBM-G), Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) or any other dedicated source of funding. Further, it is mandatory to provide support of 90/95 person days unskilled wage employment at the current rates to a PMAY-G beneficiary for construction of his /her house in convergence with MGNREGS. The PMAY-G households are also provided water, LPG and electricity connections in convergence with other relevant schemes.

The unit assistance provided to beneficiaries under PMAY-G is as per the approval of the Union Cabinet Mnimum 60% of the target at the national level is earmarked for SC/ST households. To maintain this, 60% of the target allocated to each State / UT is earmarked for SC/STs, subject to availability of eligible PMAY-G beneficiaries in the Permanent Wait List (PWL). Within earmarked targets the proportion of SC and ST is decided by the respective States/UTs from time to time.

The State/UT wise details of house constructed under Scheduled Tribe category under PMAY-G during the **last five years** is given at **Annexure 1**.

The details of central assistance funds released under Scheduled Tribes head under PMAY-G during the last three years is given at **Annexure 2**.

Providing houses to the eligible ST families is among the priority of the Government. Under PMAY-G, there is a multi-layered prioritization within the universe of eligible PMAY-G beneficiaries. Priority is first assigned on the basis of parameters reflecting housing deprivation in each category viz., SC/ST and Others. Households are prioritized based on houselessness, followed by the number of rooms; zero, one and two rooms, in that order. In a particular social category viz., SC/ST and Others, households which are houseless or living in houses with lesser number of rooms are not ranked below households living in houses with greater number of rooms.
