- (a) the details of the foreign funds received by various companies for infrastructure projects in the country during the last three years, State/UT-wise;
- (b) the names of the said companies utilizing maximum foreign funds on infrastructure projects during the said period, State/UT-wise; and
- (c) the number of employment opportunities generated as a result thereof?

ANSWER

(a). The infrastructure projects have received an inflow of USD 1070.76 million, USD 7874.53 million & USD 3247.52 million during the last three years i.e 2019-20 (from October 2019 to March 2020), 2020-21 and 2021-22 respectively. A statement indicating State wise inflows of Foreign Direct Investment (FDI) equity in the infrastructure projects is at Annexure.

(b) & (c). Infrastructure project-wise details of utilization of funds by the companies and employment generated therefrom are not maintained centrally.
