Committee to Oversee PM-SHRI Schools

5151. SHRI JAYADEV GALLA:

Will the Minister of EDUCATION be pleased to state:

- (a) whether a Committee has been established by the Government to oversee the reviewal and selection of prospective PM-SHRI schools, if so, the details thereof;
- (b) the number of schools targeted for PM-SHRI in 2022-23, State-wise;
- (c) the basis of the SQAF, if developed, key performance indicators thereof;
- (d) the process of self-registration by schools;
- (e) the funds, out of the total project cost, allocated for 2022-23, for implementation of PM-SHRI, State-wise; and
- (f) the manner in which the overall targeted number of 14500+ schools have been reached?

ANSWER

(a) to (f) The Cabinet has approved a new Centrally Sponsored Scheme named Pradhan Mantri Schools for Rising India (PM SHRI) on 7th September, 2022. These schools will showcase the implementation of the National Education Policy 2020 and emerge as exemplar schools over a period of time, and also offer leadership to other schools in the neighbourhood. They will provide leadership in their respective regions in providing high-quality education in an equitable, inclusive and joyful school environment that takes care of the diverse background, multilingual needs, and different academic abilities of children and makes them active participants in their own learning process as per the vision of NEP 2020.

Under the scheme there is a provision of setting up of more than 14500 PM SHRI Schools by strengthening the existing schools from amongst schools managed by Central government/State/UT Government/local bodies. The duration of scheme is from 2022-23 to 2026-27; after which it shall be the responsibility of the States/UTs to continue to maintain the benchmarks achieved by these schools. The total cost of the project is Rs 27360 crore spread over a period of 5 years which includes central share of Rs 18128 crore. Out of the total project cost, Rs 1800 crore has been allocated to financial year 2022-23.

Under the scheme, selection of PM SHRI schools is through Challenge Mode wherein Schools compete for support to become exemplar schools. Selection is done through a three-stage process with definite time lines, which is as follows: -

Stage-1: States/UTs would sign MoU with Centre laying down the commitments for supporting these schools for achieving specified quality assurance as PM SHRI schools.

Stage-2: In this stage, a pool of schools that are eligible to be selected as PM SHRI Schools would be identified based on prescribed minimum benchmark through UDISE+ data.

Stage-3: This stage is based on the challenge method for fulfilling certain criteria. Only the schools from the above eligible pool of schools would compete to fulfil the challenge conditions. Fulfilment of conditions would be certified by states/KVS/JNV through physical inspection.

As the schools are selected through challenge method, hence there are no predefined state/UT-wise break-up of schools. States/UTs are to recommend the list of schools to Ministry of education and an Expert committee headed by Secretary (SE&L), at Ministry of Education has been constituted to make the final school selections. The composition of the Expert committee is annexed.

To maintain the standard of PM SHRI Schools over a period of time is important. Therefore, a School Quality Assessment Framework (SQAF) has been developed to promote understanding of various dimensions of quality of school education and to help the schools to identify their strengths and areas for development. It also assists the schools to embed self-evaluation, reflective practice and responsiveness to the needs of learners in their classrooms and other learning settings.
