VIOLATION OF GUIDELINES UNDER AMRUT 2.0

NO. 52. SHRI HIBI EDEN:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether the cases of violation of guidelines framed by the Government for the Atal Mission for Rejuvenation and Urban Transformation 2.0 (AMRUT 2.0) have come to the notice of the Government and if so, the details thereof, scheme-wise and the reasons therefor along with the action taken/being taken so far by the Government in such cases;**
- (b) whether the Government has provided adequate funds under the AMRUT 2.0 scheme and if so, the details thereof along with its implementation or utilization, scheme-wise;**
- (c) whether the Government has approved drinking water supply projects spread across various divisions of Kochi Municipal Corporation and if so, the details thereof including the division number, name of the project, estimated expenditure, expected date of completion and the status of the work; and**
- (d) whether the average annual per capita availability of water in the country have come down drastically especially in Kochi Municipal Corporation at present and if so, the details thereof?**

ANSWER

(a): No Sir, no such violation have been noticed so far.

(b): Yes Sir. The total committed central assistance for AMRUT 2.0 is ₹76,760 crore for five years from FY 2021-22 to FY 2025-26. Of this, ₹66,750 is for AMRUT 2.0 projects. So far ₹5,846 crore have been released under various components of AMRUT 2.0 including ₹5,318 crore for AMRUT 2.0 projects. As on date, no utilisation certificate(s)is/are due under AMRUT 2.0.

(c): Under AMRUT 2.0, so far 26 water supply projects worth ₹164.77 crore have been approved for Kochi Municipal Corporation by Apex Committee. The details are placed at ANNEXURE-I

(d): Urban Development is a State subject. Ministry only supplements the efforts of State/ UT Governments through its various Mission/ Schemes. The average annual per capita availability of water in the country is not maintained under AMRUT 2.0.
