EMPLOYMENT IN TRIBAL AREAS

†5234. SHRI RAMSHIROMANI VERMA:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) the name of the schemes being implemented to promote/create employment in the tribal areas of the country;
- (b) the State/Union Territory-wise details of the fund allocated under the schemes during the last three years; and
- (c) the details of the work undertaken by the Government in Uttar Pradesh, particularly in Shrawasti Parliamentary constituency during the last three years and the current year?

ANSWER

MINISTER OF STATE FOR TRIBAL AFFAIRS (SMT RENUKA SINGH SARUTA)

- (a) to (c): Some of the schemes being implemented by Ministry of Tribal Affairs for promotion / creation of employment opportunities to the tribal population are as under:
- i. Under the scheme of Pradhan Mantri Janjatiya Vikas Mission (PMJVM), Tribal Cooperative Marketing Development Federation of India Limited (TRIFED), an autonomous body under the Ministry provides financial assistance to the State Governments for procurement of notified Minor Forest Produces (MFPs) at Minimum Support Price (MSP) to safeguard the livelihood of tribal MFP gatherers. It also provides financial support for value addition activities of tribal produce through setting up of Van Dhan Vikas Kendras (VDVKs) to scale up the income of the tribal people associated with these Kendras. Besides, the scheme has the provision of procurement and marketing of tribal products through empanelled tribal artisans. The State-wise details of funds sanctioned for establishment of VDVKs including Uttar Pradesh are given at **Annexure**.
- ii. National Scheduled Tribes Finance and Development Corporation (NSTFDC), a Central Public Sector Enterprise (CPSE) under the Ministry of Tribal Affairs, extends concessional loans to the eligible Scheduled Tribe persons for undertaking income

generation activities / self-employment through its implementing agencies. The prominent schemes of NSTFDC are given as under:

- i. Term Loan Scheme: NSTFDC provides Term Loan for viable projects costing upto ₹50.00 lakh per unit. Under the scheme, financial assistance is extended upto 90% of the cost of the project and the balance is met by way of subsidy/ promoter contribution/ margin money.
- ii. Adivasi Mahila Sashaktikaran Yojana (AMSY): This is an exclusive scheme for economic development of Scheduled Tribes Women. It provides loan upto 90% for projects costing upto ₹2.00 lakh at highly concessional rate of interest of 4% per annum.
- iii. Micro Credit Scheme for Self Help Groups (MCF): This is an exclusive scheme for Self Help Groups for meeting small loan requirement of ST members. Under the scheme, the Corporation provides loans upto ₹50,000/per member and maximum ₹5 Lakh per Self Help Group (SHG).
- iv. Margin Money Support Scheme for ST Entrepreneurs: Under this scheme, the eligible ST Entrepreneurs are allowed to avail financial assistance to the extent of 15% of the total project cost under Stand-Up India Scheme.

The State-wise amount disbursed under the above-mentioned schemes of NSTFDC during last three years including Uttar Pradesh is given at **Annexure**.
