Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the details of the various schemes of the Government and their achievements for skill development and development of entrepreneurship among the youth of backward and deprived society during the last three years;
- (b) whether entrepreneurship training and its importance have been included in the curriculum of schools and junior classes and if so, the details thereof; and
- (c) the details of efforts are being made to encourage youth for new startups and development of such skills particularly in North-East and Rajasthan?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(SHRI RAJEEV CHANDRASEKHAR)

(a) Under Skill India Mission, Ministry of Skill Development and Entrepreneurship (MSDE) delivers skill, Re-Skill and Up-Skill training programme and development of entrepreneurship among the youth including youth from backward and deprived society across the country through an extensive network of skill development centres/Institutes under various Schemes viz. Indian Institute of Entrepreneurship (IIE), National Institute for Entrepreneurship and Small Business Development (NIESBUD), Jan Shikshan Santhan (JSS) Scheme, Craftsman Training Scheme (CTS), and Pradhan Mantri Kaushal Vikas Yojana (PMKVY). The brief of these Schemes/Institutions are as under:

Indian Institute of Entrepreneurship (IIE), Guwahati: IIE is an autonomous Institute under the aegis of MSDE. IIE aims to promote entrepreneurship as an alternate career choice and provide handholding support to potential and early-stage entrepreneurs, by imparting entrepreneurship education and mentoring support to trainees/ beneficiaries primarily from North Eastern Region (NER). Few Schemes/Projects implemented by IIE for skill development and development of entrepreneurship among the youth of backward and deprived society during the last three years are as follows:

- 1. National Backward Classes Finance and Development Corporation (NBCFDC): IIE has implemented Short Term Training under the aegis of National Backward Class Finance Development Corporation to provide skill development training to the Backward Class youth under Pradhan Mantri Dakshta Aur Kushalta Sampann Hitagrahi (PMDAKSH) Scheme. The objective of implementing the short term skill training program through expert trainers and dedicated lab room facility is to uplift the Backward Class youth so that they can get skilled and generate sustainable livelihood and become self-reliant.
- 2. National Safai Karamcharis Finance & Development Corporation (NSKFDC): IIE has implemented Short Term Training under the aegis of National Safai Karamcharis Finance & Development Corporation (NSKFDC) to provide skill development training to the Safai Karmacharis under Pradhan Mantri Dakshta Aur Kushalta Sampann Hitagrahi (PM-DAKSH) Scheme. The objective of implementing the short term skill training program through expert trainers and dedicated lab room facility is to uplift the Safai Karmacharis so that they can get skilled and generate sustainable livelihood and become self-reliant.
- 3. National Scheduled Castes Finance and Development Corporation (NSFDC): IIE has implemented Short Term Training under the aegis of National Scheduled Castes Finance Development Corporation to provide skill development training to the Scheduled Castes youth under Pradhan Mantri Dakshta Aur Kushalta Sampann Hitagrahi (PM-DAKSH) Scheme. The objective of implementing the short term skill training program through expert trainers and dedicated lab room facility is to uplift the Scheduled Castes youth so that they can get skilled and generate sustainable livelihood and become self-reliant.

The details of beneficiaries under above projects for the youth from backward and deprived society are placed at *Annexure-I*.

National Institute for Entrepreneurship and Small Business Development (NIESBUD): NIESBUD is an autonomous entrepreneurship development Institute under the aegis of MSDE. NIESBUD aims to promote entrepreneurship as an alternate career choice and provide handholding support to potential and early-stage entrepreneurs, by imparting entrepreneurship education and mentoring support to trainees/ beneficiaries.

The details of beneficiaries under few of the projects implemented by NIESBUD for the youth from backward and deprived society are placed at *Annexure-II*.

Craftsmen Training Scheme (CTS): This scheme is for providing long-term training through Industrial Training Institutes (ITIs) across the country. The ITIs offers a range of vocational/skill training courses covering a large number of economic sectors with an objective to provide skilled workforce to the industry as well as self employment of youth. At present, there are 14,953 ITIs established across the country out of which 3,246 are Government aided ITIs and 11,707 are Private ITIs.

The details of trainees from backward and deprived society enrolled in Industrial Training Institutes (ITIs) under Craftsmen Training Scheme (CTS) in the country State wise for last three years are placed at *Annexure-III*.

Pradhan Mantri Kaushal Vikas Yojana (PMKVY): PMKVY Scheme is for imparting skill development training through Short-Term Training (STT) and recognition of Prior Learning (RPL) to youth across the country.

The details of trainees from backward and deprived society benefitted under PMKVY Scheme in the country for last three years are placed at *Annexure-IV*.

The details of the various initiatives/programme taken by Ministry of Rural Development for promoting entrepreneurship are given below:

Rural Skills Division, Ministry of Rural Development (MoRD) is implementing two welfare Schemes in the field of skill development for rural poor youth under the umbrella of National Rural Livelihoods Mission (NRLM) for their gainful employment to enable them to get out of poverty:

- I. Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY): DDU-GKY is a placement linked skill development program started in September 2014 for rural poor youth in the age group of 15-35 years. DDU-GKY guidelines provide for earmarking 50% of the funds for SCs and STs and 15% for minorities. Further, one third beneficiaries of the respective categories including general category covered under the scheme should be women.
- II. Rural Self Employment Training Institutes (RSETIs): RSETI is a Bank led MoRD funded training Institution established by the Sponsor Banks in their Districts, to provide training for Skill and Entrepreneurship Development. MoRD extends financial support for the construction of RSETI building and also bears the cost of training the Rural Poor candidates. Any unemployed youth in the age group of 18-45 years having an aptitude to take up self-employment or wage employment and having some basic knowledge in the related field can undergo training at RSETI. Some of the trained candidates may also seek regular salaried jobs / wage employment.

The number of rural poor candidates (including those belonging to backward and deprived society) trained and placed/ settled under DDU-GKY & RSETI during the last three years and current year are given as under:

(b) The Department of School Education and Literacy is implementing an initiative of Vocationalisation of School Education under the umbrella of the Centrally Sponsored Scheme 'SamagraShiksha'. The Scheme aims at integrating Vocational Education with general academic education in all Secondary/Senior Secondary schools; enhancing the Employability and Entrepreneurial abilities of the students, providing exposure to work

environment; and generating awareness amongst students about various career options so as to enable them to make a choice in accordance with their aptitude, competence and aspirations. The scheme covers Government and Government aided schools.

Under Vocational Education component of 'SamagraShiksha', NSQF compliant vocational courses are offered to the students from class 9th to 12th in the schools covered under the scheme. Employability Skills module has been made a mandatory part of the vocational Courses. It consists of Communication Skills, Self-Management Skills, Information and Communication Technology Skills, Entrepreneurship Skills and Green Skills.

At the Secondary level i.e. Class 9th and 10th, vocational modules are offered to the students as an additional subject at Senior Secondary level, i.e. Class 11th and 12th, vocational courses are offered as a compulsory (elective) subject. Vocational Courses are selected on the basis of notional hours, age & educational qualification prescribed and suitability for school students.

As of now, 17,761 schools have been approved under the Scheme out of which the scheme has so far been implemented in 13,161 schools with the reported total enrolment of 18,59,275 students.

(c) Yes, Sir. Efforts are being made to encourage youth for new startups and development of skills particularly in North Eastern Region (NER) and Rajasthan, details of few Schemes/Projects are given below:

Indian Institute of Entrepreneurship (IIE): (i) IIE has been nominated as Nodal agency by North Eastern Council (NEC) for developing Entrepreneurship Development Centres & Incubation Centres in the higher education institution of North East for supporting startups in North Eastern Region (NER). (ii) IIE is empaneled as National Resource Organisation (NRO) for the implementation of Startup Village Entrepreneurship Programme (SVEP) under the Ministry of Rural Development. IIE is providing Mentoring & Handholding support under SVEP in six blocks of Assam (Barbhag, Chandrapur, Dangtol, Khowang, Pachim Kaliabor, and Ujani Majuli).

National Institute for Entrepreneurship and Small Business Development (NIESBUD): NIESBUD is having an extension centre at NSTI(W), Jaipur, Rajasthan. NIESBUD aims to promote entrepreneurship as an alternate career choice and provide handholding support to potential and early-stage entrepreneurs, by imparting entrepreneurship education and mentoring support to the trainees/ beneficiaries.

Incubator component under DAY-NRLM, Department of Rural Development, Ministry of Rural Development, Government of India: The National Rural Economic Transformation Project (NRETP), a sub Scheme under DAY-NRLM has launched Incubator component under non-Farm livelihood initiative by on boarding of dedicated Incubators who will work closely with the State Rural Livelihood Missions (SRLMs) to incubate growing micro-enterprises and facilitate their self-sustenance, thereby creating local employment opportunities. The objective of the initiative is to pilot strategies to scale up 150 existing women-owned/ women-led growth-oriented enterprises (from SHGs ecosystem) in a State and create models for replicability. The enterprises supported under incubator should be from manufacturing and service sectors. As of February 2023, Incubator component has been approved and under implementation in four States Assam, Bihar, Karnataka, and West Bengal.
