(a) and (b): The procurement of Wheat and paddy is undertaken by Government agencies for Central Pool which covers various welfare schemes of Government including PMGKAY. Scheme specific procurement of foodgrains is not done for central pool. The State-wise procurement of wheat and paddy (in terms of rice) in Central Pool during the last three years and current year is at Annexure-I & II respectively.

The State Government/UTs procures sugar from the open market through a transparent system and make it available to the beneficiaries under the PDS to Antyodaya Anna Yojana (AAY) families. The task of distribution of sugar is undertaken by the concerned States/UTs.

The Department of Consumer Affairs has provisioned pulses out of the Price Stabilization Fund buffer for distribution @1kg per household per month, free of cost.

Department of Food and Public Distribution distributed wheat and rice under PMGKY in seven phase. The phase wise financial outlay and subsidy incurred as on 31.03.2023 are as under:

The Central Government is reimbursing a fixed subsidy of Rs. 18.50 per kg @ 1 Kg per month per Antyodaya Anna Yojana (AAY) families to participating States/UTs. The role of Central Government is limited to providing the agreed amount of subsidy.
