(a): Details of covered storage capacity of Food Corporation of India (FCI) increased during last three years under Public-Private Partnership (PPP) mode are as given below:

**The State wise details of capacity created by FCI under the above mentioned Schemes in the last three years are at Annexure-I.**

**FCI also augment storage capacity by hiring of godowns under Private Warehousing Scheme (PWS). As on 01.03.2023, a covered storage capacity 6.42 LMT (including Uttar Pradesh) is hired.**

**(b): No godowns constructed under Public-Private Partnership (PPP) during the last three years in Hathras Parliamentary Constituency.**

**However, godowns of 0.31 LMT storage capacity (owned + hired) are available with FCI in Hathras Parliamentary Constituency.**

**(c) & (d):**

**Rail Side Silos-**

**The Railway siding silos are being constructed under PPP mode as per the 2016 Action Plan. In the state of Uttar Pradesh a Capacity of 4.5 LMT Silos at 9 locations was proposed out of which 1 LMT at 2 location completed in FY 2022-23 and 3.5 LMT at 7 locations is under construction.**

**Hub & Spoke Silos-**

**Further, Silos with capacity 9.25 LMT at 22 locations have been awarded under Hub & Spoke model Phase 1.**

**PEG Scheme-**

**1.68 LMT Capacity is under construction at 12 Locations in Uttar Pradesh. 4.51 LMT Capacity at 25 locations is under tender process under PEG Scheme of which 0.25 LMT Capacity is envisaged in Hathras. 4.51 LMT Capacity (including 0.25 LMT in Hathras) is under tender process at 25 locations under PEG Scheme.**
