BSNL REVIVAL PACKAGE

5373. SHRI KARTI P. CHIDAMBARAM:

Will the Minister of COMMUNICATIONS be pleased to state:

(a) the details of the Rs. 1.64 lakh crore revival package approved for BSNL in July 2022 as well as Rs. 74,000 crore package approved in October 2019;

(b) the details of utilisation of the two revival packages;

(c) whether BSNL and BBNL are loss making CPSEs, and if so, the details of their profit/loss statements starting FY 2014-15 including provisional data for current year;

(d) the reasons for approving merger of loss making entities BSNL and BBNL by the Government in 2022;

(e) whether the BharatNet project will be carried out by the merged entity, and if so, the details thereof and if not, the reasons therefor;

(f) the targets set under BharatNet including length of Optical Fibre Cable (OFC), number of panchayats where OFC laid, number of panchayats service ready vis-a-vis achievements of these targets, State/UT-wise; and

(g) the details of the deadline for completion of BharatNet project?

ANSWER

MINISTER OF STATE FOR COMMUNICATIONS (SHRI DEVUSINH CHAUHAN)

(a) & (b) The Union Cabinet on 23.10.2019, approved the revival plan for BSNL and MTNL. It inter-alia approved the reduction in employee costs through Voluntary Retirement Scheme (VRS), debt restructuring by raising of sovereign guarantee bonds, administrative allotment of spectrum for 4G services through capital infusion, monetization of core and non-core assets and in-principle approval of merger of BSNL and MTNL.

Further on 27.07.2022, to transform BSNL into a viable Public Sector Undertaking, the Union Cabinet approved a revival package for BSNL amounting to Rs 1.64 lakhs crores. The revival measures inter-alia focus on infusing fresh capital for upgrading BSNL services, allocating spectrum,

de-stressing its balance sheet and augmenting its fibre network by merging Bharat Broadband Nigam Limited (BBNL) with BSNL. The details of utilization of two revival packages is attached at **Annexure-I**.

The merger will result in operation, maintenance and utilization with one agency, which will bring synergy in terms of cost reduction, revenue enhancement and better utilization of existing assets.
