#### SKILL DEVELOPMENT IN RAJASTHAN

538. COL. RAJYAVARDHAN RATHORE:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the steps being taken by the Government for creating an entrepreneurial ecosystem in the country, inclusive of the marginalized self-employed labour-force;
- (b) the fund allocation for such schemes and initiatives during the past five years, especially for Rajasthan, year-wise;
- (c) the number of youths connected with skill development schemes till date in Rajasthan in comparison to other States; and
- (d) the data highlighting and the scope provided by the Government through these schemes to benefit the youth, especially in Jaipur Rural?

### **ANSWER**

THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(SHRI RAJEEV CHANDRASEKHAR)

- (a) to (b): To create an enabling ecosystem through entrepreneurship education, training, advocacy and easy access to entrepreneurship network, Ministry of Skill Development and Entrepreneurship (MSDE) has been working for promoting entrepreneurial talents including marginalized self employed labour-force in the country through National Institute for Entrepreneurship and Small Business Development (NIESBUD) and Indian Institute of Entrepreneurship (IIE). The details of the various initiatives taken by MSDE are placed at *Annexure-I.* Further, the details of the various initiatives taken by other Ministries/Departments for promoting entrepreneurial talents in the country including Rajasthan are placed at *Annexure-II.*
- **(c) to (d):** The details of the number of beneficiaries connected with skill development under various initiatives taken by MSDE are as under:
- 1. Apprenticeship training: Apprenticeship training under Apprentices Act, 1961 and the Rules thereof is one of the key Scheme for skill development of youth in the country including Rajasthan and contributes to 'Skill India'. State-wise number of youths connected with skill development schemes under Apprenticeship Training including Rajasthan from FY 2016-17 till 30.01.2023 is placed at Annexure-III.

41,836 apprentices in Rajasthan including 9,138apprentices in Jaipur District, have been enrolled for apprenticeship training since its inception i.e., FY 2016-17 to 30.01.2023.

# 2. Pradhan Mantri Kaushal Vikas Yojana (PMKVY): Ministry of Skill Development and Entrepreneurship (MSDE) is implementing Pradhan Mantri Kaushal Vikas Yojana (PMKVY) with an objective to deliver skills to youth of the country through Short Term Training (STT) and Recognition of Prior Learning

(RPL).

10,94,168 beneficiaries in Rajasthanincluding 1,99,033beneficiaries in JaipurDistrict, have beentrained/oriented under the Scheme of PMKVY till 31.12.2022. Details of candidates trained/oriented Pan India are placed at *Annexure-IV*.

3. Jan Shikshan Sansthan (JSS): The Ministry of Skill Development & Entrepreneurship is implementing the Scheme of Jan Shikshan Sansthan through NGOs to impart skill training in non-formal mode to non-literate, neo-literates, persons with rudimentary level of education up to eighth and school dropouts up to 12<sup>th</sup> standard in the age group of 15-45 years in rural areas and urban slums. The priority groups are women, SC, ST, Minorities and other backward sections of the society. The objective of the JSS scheme is to increase household income by promoting self/wage employment.

42,566 beneficiaries in Rajasthanincluding 6,835 beneficiaries in Jaipur District beneficiaries have been trained under the Scheme of Jan Shikshan Sansthan during the period 2018-19 till 2022-23. Details of the candidates trained Pan India are placed at *Annexure-V*.

The details of the various initiatives taken by MSDE for Entrepreneurship Development are as given below:

- (i) **Pilot project on Entrepreneurship Development in Holy Cities** is a project of the MSDE implemented by NIESBUD and IIE which aims to catalyze local entrepreneurial activities through involvement of potential and existing entrepreneurs, unemployed youth, college dropouts, youth from backward communities. The project is being implemented in Bodh Gaya, Kollur, Haridwar, Puri, Pandharpur and Varanasi. Total beneficiaries trained under the project are 8,600.
- (ii) Organizing Workshops in Artisan Melas and Haats: MSDE is implementing a project through NIESBUD to undertake the initiative for organising workshops for capacity building and providing entrepreneurial knowledge to the artisans during the Melas and Haats with a view to value addition in the existing Products of participants, creating financial and market linkages and linking their products with e-commerce platforms and making their businesses compliant to government regulations.
- (iii) Creating Entrepreneurial Climate through Training of Trainers and Entrepreneurship Development Programme in Jan Shikshan Sansthan (JSS): MSDE is implementing a project through NIESBUD for Creating Entrepreneurial Climate through Training of Trainers and Entrepreneurship Development Programme in Jan Shikshan Sansthan (JSS) for creating, fostering and promoting the spirit of entrepreneurship among the various target groups through Capacity Building, Incubation Support, Mentoring and Handholding.

NIESBUD has organized a Trainer's Training Programme on Employability, Entrepreneurship & Life Skills at Jaipur District for 55 JSS Trainers of Rajasthan.

(iv) **PM YUVA Pilot Project** MSDE implemented PM-YUVA Pilot Project (from November, 2019 to March, 2022) towards creating an enabling ecosystem through entrepreneurship education, training, advocacy and easy access to entrepreneurship network. It focused on students/trainees and alumni coming out from Skilling ecosystem {i.e. Industrial Training Institutes (ITIs), Polytechnics, Pradhan Mantri Kaushal Kendras (PMKKs) and Jan Shikshan Sansthans (JSSs)}. The project was implemented through organisations having experience in entrepreneurship development, entrepreneurship training as well as mentoring and handholding in Ten States and Two Union Territories (viz. Assam, Bihar, Kerala, Maharashtra, Meghalaya, Tamil Nadu, Telangana, Uttar Pradesh, Uttarakhand, West Bengal, Delhi and Puducherry). The details of entrepreneurial activity under the PM-YUVA Project are as under:

The details of the various initiatives taken by other Ministries/Departments for promoting entrepreneurial talents in the country are as given below:

1) Prime Minister's Employment Generation Programme (PMEGP): Ministry of MSME is implementing Prime Minister's Employment Generation Programme (PMEGP) through Khadi and Village Industries Commission (KVIC), for promoting entrepreneurs in setting up of new units in the non-farm sector. It aims to bring together widely dispersed traditional artisans/ rural and urban unemployed youth and give them self-employment opportunities to the extent possible, at their doorstep.

Under PMEGP, General Category beneficiaries can avail Margin Money subsidy of 25% of the project cost in rural areas and 15% in urban areas. For beneficiaries belonging to Special Categories, such as Scheduled castes, Scheduled tribes, OBCs, Minorities, Women, Transgender, Ex-servicemen, Differently Abled, beneficiaries belonging to Northeastern Region, Aspirational District, Hill and Border areas, etc., the Margin Money subsidy is 35% in rural areas and 25% in urban area. The maximum cost of project is Rs.50 lakh in the manufacturing sector and Rs.20 lakh in the service sector. Also,own contribution for beneficiaries belonging to Special Categories is 5% of project cost as compared to 10% for General Category beneficiaries.

2) Entrepreneurship and Skill Development Programme (ESDP): Entrepreneurship and Skill Development Programme (ESDP) scheme of O/o DC(MSME)runs with the objective to motivate young persons (Men & Women) representing different sections of the society including SC/ST/ Women, physically handicapped, Ex-servicemen and BPL persons to consider self-employment or entrepreneurship as a career options. It is Central Sector scheme which is implemented across country including Rajasthan, without any state specific location.

3) Pradhan Mantri Mudra Yojana (PMMY): The Pradhan Mantri MUDRA Yojana (PMMY) was launched by Department of Financial Services under Ministry of Finance on 08.04.2015 to extend collateral free loans up to Rs 10 lakh to individuals to enable them to set up or expand their business activities. The Scheme facilitates loans in three categories namely Shishu (up to Rs. 50.000), Kishore (Rs 50,000 to Rs 5 lakh) and Tarun (Rs 5 lakh to Rs 10 lakh) for income generating activities in Manufacturing, Trading Services sector and also for the activities allied to agriculture. PMMY is being implemented across the country including Rajasthan. Data in respect of Jaipur District of Rajasthan, since inception of the Scheme is as under:

4) Stand Up India Scheme (SUPI): The Stand-Up India Scheme was launched by Department of Financial Services under Ministry of Finance on 05 April, 2016 and has been extended upto the year 2025. The objective of the Stand-Up India Scheme is to facilitate loans from Scheduled Commercial Banks (SCBs) of value between Rs 10 lakh and Rs 1 Crore to at least one Scheduled Caste (SC) or Scheduled Tribe (ST) borrower and one-woman borrower per bank branch for setting up a greenfield enterprise in manufacturing, services or trading sector and also for the activities allied to agriculture. The Scheme focuses on hitherto underserved segments of society understood to be facing significant hurdles due to lack of advice/mentorship as well as inadequate and delayed credit. Over the years a handholding ecosystem of different agencies has evolved for supporting prospective beneficiaries through financial training, skilling entrepreneurship development, work shed requirement, mentoring application filling/ DPR preparation etc. Stand Up Mitra Portal being managed by SIDBI provides a digital platform to support enterprises promotion among potential entrepreneurs from SC, ST and Women Category through handholding support at pre-disbursement and post- disbursement level.

SUPI is being implemented across the country including Rajasthan. Data in respect of Jaipur District of Rajasthan, since inception of the Scheme is as under:
