#### FOOD ADULTERATION

5425. DR. K. JAYAKUMAR:

- (a) the quantity of adulterated food that has been confiscated from the year 2014 to 2022 from leading business houses;
- (b) the punishments/penalties that have been imposed on them, value-wise;
- (c) whether this punishment/penalty is adequate or can be raised to stringent levels to effectively discourage food adulteration; and
- (d) the action plan to complete the targets in case these have not been met, year-wise?

## THE MINISTER OF STATE CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (SHRI ASHWINI KUMAR CHOUBEY)

(a) to (d): Food Safety and Standards Authority of India (FSSAI) through State/UTs and its regional offices conduct regular surveillance, monitoring, inspection and random sampling of food products to check compliance of the standards laid down under Food Safety and Standards Act 2006, Rules and Regulations made thereunder. In cases where the food samples are found to be non-conforming, penal action has been initiated against the defaulting Food Business Operators as per provisions of FSS Act, Rules and Regulations made thereunder.

No separate enforcement data regarding quantity of adulterated food that has been confiscated from the year 2014-2022 from leading business houses is maintained centrally by the Food Safety and Standards Authority of India, however based on the information made available by the states/UTs the details of various kinds of food samples received, analyzed, found non-conforming and action taken during 2019-20, 2020-21 and 2021-22 is at **Annexure.**
