UNORGANISED AND GIG WORKERS

569. SHRI KARTI P. CHIDAMBARAM:

Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a)whether the Government held consultations with labour unions/associations representing unorganised and gig workers before launching the e-SHRAM portal;
- (b)if so, the names of these associations as well details of meetings held thereof;
- (c)whether the Government has included labour unions/associations representing unorganised and gig workers in the e-SHRAM portal registration process to help workers get registered and if so, the names of these associations thereof;
- (d)the number of labourers/workers who are eligible to register on e-SHRAM portal, State-wise;
- (e)the number of labourers/workers registered till now on e-SHRAM portal since its launch in August 2021, State-wise;
- (f)whether the Government has set up any physical centres to assist workers in the registration process and if so, the details thereof; and
- (g)the data privacy measures taken by the Government to safeguard the registered workers' data?

ANSWER

MINISTER OF STATE FOR LABOUR AND EMPLOYMENT (SHRI RAMESWAR TELI)

(a) & (b): Yes Sir. Prior to the launch of e-SHRAM portal, interaction was held with Trade Union Leaders. During the interaction, features and objectives behind the development and launch of e-SHRAM portal were explained. The Labour Unions/ Associations who attended the e-SHRAM discussion session held on 24th August 2021 are Bhartiya Contd..2/- Mazdoor Sangh (BMS), Hind Mazdoor Sabha (HMS), Centre of Indian Trade Union (CITU), All India Trade Union Congress (AITUC), Trade Union Coordination Centre (TUCC), Self Employed Women's Association (SEWA), United Trades Union Congress (UTUC), National Front of India Trade Unions (NFITU)

(c): The ministry has been conducting regular interactions with the Trade Union Associations of unorganised and gig workers with regard to registrations in the e-SHRAM portal.

(d) & (e): Any unorganised worker having age lying between 16-59 years, who is not a member of EPFO/ESIC, and not a member of Government services/PSUs and not an income-tax payee is eligible to register on e-SHRAM portal. The State-wise number of workers registered on e-SHRAM portal as on 31/01/2023 is as per Annexure.

(f): Workers can self-enrol themselves on e-SHRAM portal. e-SHRAM has provided multi-channel registration facility to unorganised workers across country. Common Service Centre-Special Purpose Vehicle with its more than 4 lakh Village Level Entrepreneurs have been onboarded to provide registration facilities to workers on e-SHRAM. State Sewa Kendras (SSKs) have also been onboarded to facilitate unorganised workers in registration process. e-SHRAM has also been integrated with UMANG mobile application to provide registration facility to the unorganised workers through a mobile app.

(g): The Unique Identification Authority of India (UIDAI) guidelines related to Security and privacy of data, maintenance of data vault to store such information, security audit of portal and other best practices are being implemented to safeguard the data of registered workers.
