Existing Schools in UT of Ladakh

Will the Minister of **Education** be pleased to state:

(a) whether the existing Schools in UT of Ladakh are having all basic mandatory criteria such as infrastructures, classrooms, playgrounds, study materials, sport equipment, computer and digital lab and other essentials;

(b) if so, the details thereof and if not, the reasons therefor;

(c) the detail of the schools upgraded in the last five years and whether the Government has proposed to upgrade/open new schools at all levels in UT of Ladakh;

(d) if so, the details thereof and if not, the reasons therefor;

(e) whether the Government is planning to affiliate all the existing Private Schools in UT of Ladakh with CBSE; and

(f) if so, the reasons therefor?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SMT. ANNPURNA DEVI)

(a) to (d): Education is in the concurrent list of the Constitution and majority of schools are under the domain of respective State/UT Government. The Centrally Sponsored Scheme of Samagra Shiksha is an overarching scheme for school education covering all levels from pre-primary to senior secondary, under which financial assistance is provided to the States and UTs for various activities which include opening/strengthening of new schools up to senior secondary level, strengthening school infrastructure etc. Under the scheme, State/UT Governments send their proposals and recommendations through Annual Work Plan and Budget (AWP&B) every year to the Department. Establishment of new schools, new classroom, repair of existing room and other infrastructure related civil work is also included in the proposal as per requirement of State/UT. A Project Approval Board, under the chairmanship of Secretary (SE&L), considers such various proposals/recommendations sent by the States/UTs on a whole irrespective of region and geographical area in its annual meeting and approves the physical and financial components of various activities as per the guidelines of the scheme.
