ICT under Samagra Shiksha Yojana

†682. SHRIMATI HEMA MALINI:

Will the Minister of EDUCATION be pleased to state:

(a) whether under the Information and Communication Technology (ICT) component of the

Samagra Shiksha Yojana, provision has been made to provide computer literacy and

computer-based learning to children by preparing and implementing curriculum-based

interactive multimedia, digital books, virtual labs etc. across the country;

(b) whether smart classes and ICT labs. are being set up in the schools in the light of the

above provision; and

(c) the number of schools where ICT labs. in smart classes have been approved, so far and the

details thereof, State-wise?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SHRIMATI ANNPURNA DEVI)

(a) Education is in the Concurrent list of the Constitution and majority of the school are

under the administrative control of respective State Government and UT Administration. The

Department of School Education and Literacy with effect from 2018-19 has launched an

Integrated Centrally Sponsored Scheme for School Education- Samagra Shiksha. The scheme

has now been aligned with the recommendations of NEP 2020 to ensure that all children have

access to quality education with an equitable and inclusive classroom environment which

should take care of their diverse background, multilingual needs, different academic abilities

and make them active participants in the learning process. Under the scheme, financial

assistance is provided to States and UTs for undertaking various activities for universalisation

of school education including setting up of ICT Labs and Smart Class rooms.

The ICT and Digital Initiatives component of Samagra Shiksha covers Government

Schools having classes VI to XII. The provisions regarding the same are as under:

A. Budgetary provisions

The non- recurring/recurring grant under 'ICT and Digital Initiatives' for schools is available to the States and UTs for following two options:

Option I: Under this option, schools which have not availed the ICT facility earlier can either opt for ICT or smart classrooms as per their requirement and need. In case of more than 700 enrolments, an additional ICT lab can also be considered.

Option II: Under this option, schools which have already availed the ICT facility earlier can avail smart classrooms/tablets as per the norms of the scheme.

B. Financial provisions

ICT Lab: A non-recurring grant of up to Rs. 6.40 lakh per school and recurring grant of upto Rs. 2.40 lakh per school per annum for a period of 5 years.

Smart Classrooms: The non-recurring grant for Smart Class rooms is of Rs. 2.40 lakh and the recurring grant is Rs. 0.38 lakh

To facilitate online education, a comprehensive initiative called PM eVIDYA has been initiated as part of Atma Nirbhar Bharat Abhiyaan on 17th May, 2020, which unifies all efforts related to digital/online/on-air education to enable multi-mode access to education. The initiative includes:

- DIKSHA (one nation, one digital platform) is the nation's digital infrastructure for providing quality e-content for school education in states/UTs and QR coded Energized Textbooks for all grades are available on it.
- One earmarked Swayam Prabha TV channel per class from 1 to 12 (one class, one channel).
- Extensive use of Radio, Community radio and CBSE Podcast- Shiksha Vani.
- Special e-content for visually and hearing impaired developed on Digitally Accessible Information System (DAISY) and in sign language on NIOS website/ YouTube.
- (b) & (c): The details of the ICT Labs and Smart Class rooms sanctioned State / UT wise are at Annexure.
