**BENEFICIARIES UNDER PMAY-G**

863. SHRI R.K. SINGH PATEL:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the number of eligible beneficiaries under Pradhan Mantri Awas Yojana - Gramin (PMAY-G) during each of the last three years and the current year, State and district-wise particularly in Uttar Pradesh and Bundelkhand region;
- (b) the number of houses allotted in Uttar Pradesh, district-wise particularly in Banda and Chitrakoot including Bundelkhand region;
- (c) whether the Government proposes to increase the number of beneficiaries under PMAY-G;
- (d) if so, the details thereof and if not, the reasons therefor;
- (e) whether the Government proposes to provide houses for all the people in rural areas; and
- (f) if so, the time by which the said target is likely to be achieved?

(a) & (b) The State-wise number of houses sanctioned to the eligible beneficiaries under Pradhan Mantri Awaas Yojana- Gramin (PMAY-G) during each of last three years and the current year, particularly in Uttar Pradesh is given in **Annexure-I**.

The Bundelkhand Region comprises of Banda, Chitrakoot, Hamirpur, Jalaun, Jhansi, Lalitpur, & Mahoba of Uttar Pradesh and Chhatarpur, Damoh, Datia, Panna, Sagar and Tikamgarh districts of Madhya Pradesh. The details of houses sanctioned to eligible beneficiaries in Banda and Chitrakoot including Bundelkhand region, during each of last three years and the current year is given in **Annexure-II**.

(c) to (f) The Union Cabinet had approved the overall target of construction of 2.95 crore houses by 31<sup>st</sup> March, 2024 based on the number of households derived from SECC 2011, against which a total of 2.83 crore houses have been sanctioned by the States/UTs and 2.15 crore houses have been completed as on 03.02.2023. At present, there is no proposal under consideration for enhancing the coverage and target of the scheme.
