## Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) whether the Government has granted funds to the implementing agencies for setting up Old Age Homes in the country;
- (b) if so, the total funds granted to such agencies during the last three years, State/UT-wise; and
- (c) whether any new proposals for opening such homes are pending with the Government and if so, the details thereof and the action taken thereon?

## ANSWER MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT

(SHRI A. NARAYANASWAMY)

(a) to (c): The Department of Social Justice and Empowerment is running Integrated Programme for Senior Citizens (IPSrC), a component of Atal Vayo Abhyuday Yojana (AVYAY) under which grant in aid is provided to implementing agencies for running and maintenance of projects like senior citizen homes, continuous care homes, etc. Therefore, the Department does not provide grant in aid for setting up/ construction of senior citizen homes. The details of grant in aid released to implementing agencies for running and maintenance of projects under IPSrC during last 3 years are at **Annexure**.

Adding new projects for financial assistance under ISPrC is a continuous process comprising seeking data on gap/ uncovered districts from States/ UTs online on e-Anudaan portal, inviting applications for new projects accordingly, selection of the project on the basis of the recommendations of the State/ UT concerned.
