**INSUFFICIENT FUNDS UNDER MGNREGS**

881. SHRI KALYAN BANERJEE:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether it is a fact that insufficient funds are being provided to States under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) head and due to which MGNREGS labours are not getting their dues in time and getting less job opportunities thereunder;
- (b) the details of the funds demanded and sanctioned/released under MGNREGS during the last three years till December, 2022; and
- (c) the action taken by the Government to release all the payments along with the State-wise demand thereof?

(a) to (c) Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) is a demand driven wage employment scheme and funds are released to the States/UTs on the basis of "agreed to" Labour Budget (LB) and performance of the States/UTs during the financial year. Fund release to States/UTs is a continuous process and Central Government is committed to making funds available keeping in view the demand for work on the ground.

No State/UT-wise financial allocation is made under Mahatma Gandhi NREGS.

State/UT-wise details of fund released under Mahatma Gandhi NREGS in the last three financial years and current financial year 2022-23 (as on 31.12.2022) is given at **Annexure**.
