(a) to (c): The focus of the Department of Social Justice and Empowerment is on the welfare of the poorest households of the socially, educationally and economically marginalized sections of the society including Scheduled Castes (SCs), Other Backward Classes, Senior Citizens, Victims of Alcoholism and Substance Abuse, Transgender Persons, Beggars, Denotified and Nomadic Tribes (DNTs), Economically Backward Classes (EBCs) and Economically Weaker Section (EWS). This Department has merged some of its previous schemes into new umbrella schemes for their better implementation and has been implementing these schemes for the welfare of public throughout the country including Rajasthan state. The details and names of all such schemes of the department are given at **Annexure**.
