NO. 201. SHRIMATI BHAVANA PUNDALIKRAO GAWALI: SHRI KRUPAL BALAJI TUMANE:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:-

- (a) the total amount of funds disbursed under Prime Minister Street Vendor's AtmaNirbhar Nidhi (PM-SVANidhi) scheme and the number of beneficiaries in the country, State-wise particularly in Maharashtra;
- (b) the total amount of loan disbursed by each type of financial institution participating in the said scheme and the number of beneficiaries served under the said scheme, State-wise, particularly in Maharshtra;
- (c) the total number of vending certificates or Identity Cards (ID cards) issued to street vendors in Maharashtra by Urban Local Bodies (ULBs) during the last five years and the current financial year, district-wise;
- (d) whether the Government has taken notice of the cases of ULBs refusing to issue vending certificates or ID cards across the country;
- (e) if so, whether any appellate mechanism exist in this regard and if so, the details thereof; and
- (f) the details to the number of financial literacy and capacity building programmes conducted by the Government and the number of applications received along with the users of web portal under PM-SVANidhi Scheme in the country, State/district-wise, particularly in Maharashtra?

STATEMENT REFERRED TO IN REPLY TO THE LOK SABHA STARRED QUESTION NO. *201 DUE FOR ANSWER ON 03.08.2023 REGARDING DISBURSEMENT OF FUNDS UNDER PM SVANIDHI SCHEME

- (a): The State-wise details of total amount of funds disbursed and number of beneficiaries across the country including for the State of Maharashtra under Pradhan Mantri Street Vendor's AtamNirbhaNidhi (PM SVANidhi) Scheme are at Annexure-I.
- (b): The details of total amount of loan disbursed by each type of Financial Institution participating in the PM SVANidhi Scheme and total number of beneficiaries across the country including for the State of Maharashtra are at Annexure-II.
- (c): During 01.04.2018 to 27.07.2023, total 29,987 Certificate of Vending (CoVs) and 21,683 Identity Cards (ID cards) have been issued to the street vendors by the Urban Local Bodies in the State of Maharashtra. District-wise details are at Annexure-III.
- (d) & (e): As per the provision of Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014, issuance of CoV and ID Card is the responsibility of Town Vending Committee under administrative control of State Govt. Section 20 of the said Act empowers the appropriate Government to constitute one or more Grievance Redressal Committee (GRC) for the purpose of addressing the grievances or disputes of street vendors.

(f): Digital onboarding of street vendors is an integral component of PM SVANidhi Scheme. As such, on-boarded beneficiaries are trained in debit and credit transactions by conducting penny drop transaction within a week of loan disbursement by the concerned Lending Institutions. As on 27.07.2023, over 20 lakh street vendors are digitally active.

In addition, the guidelines of "Support to Urban Street Vendor (SUSV)" under centrally sponsored scheme of Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM) prescribe that Urban Local Body (ULB) will organize sessions on financial literacy for identified street vendors with support of resource organization and field staff.

As on 27.07.2023, a total of 69.44 lakh eligible applications have been received under the PM SVANidhi Scheme. The details of number of eligible applications received alongwith the users of web portal under PM SVANidhi Scheme across the country including district-wise data for the state of Maharashtra are at Annexure-IV. Apart from this, there are 2,14,636 institutional users onboarded on PM SVANidhi Portal.
