#### **DEVELOPMENT OF ECO-TOURISM CIRCUITS UNDER SDS**

- (a) the details of the Eco-Tourism Circuits developed in the country including Uttar Pradesh and Odisha under the Swadesh Darshan Scheme (SDS);
- (b) the funds sanctioned for the said tourism circuits during the last three years;
- (c) the number of projects in Uttar Pradesh and Odisha under the said tourism circuit which are not completed yet and the date by which the said projects are likely to be completed;
- (d) whether the Government proposes to cover Hastinapur Wildlife Sanctuary and Nabarangpur Wildlife Sanctuary in the said circuit under SDS in consultation with the State Government; and
- (e) if so, the details thereof?

STATEMENT IN REPLY TO PARTS (a) TO (e) OF LOK SABHA STARRED QUESTION NO.†\*241 ANSWERED ON 07.08.2023 REGARDING DEVELOPMENT OF ECO-TOURISM CIRCUITS UNDER SDS

(a) to (e): The Ministry of Tourism, Government of India launched 'Swadesh Darshan Scheme' (SDS) in the year 2014-15 for integrated development of Theme-Based Tourist Circuits in the country. This Ministry has sanctioned a total of 76 projects for an amount of ₹ 5303.64 crore across the country under various identified thematic circuits of SDS including 08 projects in Uttar Pradesh and 01 project in Odisha. A total of 06 projects have been sanctioned under the Eco Circuit theme of SDS in different States for a total amount of ₹ 415.11 crore, the detail of these projects are as under:

'Swadesh Darshan Scheme' (SDS) has been revamped as 'Swadesh Darshan 2.0 (SD2.0)' with the objective to develop sustainable and responsible tourism destinations. The scheme guidelines envisage selection for Destinations based on State Perspective Plan (SPP) prepared by the States. The SPP submitted by the State Government of Uttar Pradesh and also Odisha did not included Hastinapur or Nabarangpur Widlife Sanctuaries for development. However, the Ministry of Tourism has identified 'Prayagraj' & 'Naimisharanya' in Uttar Pradesh and 'Koraput' in Odisha as destinations for development under SD2.0.
