*259. SHRIMATI SAJDA AHMED:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the outcome of the skill development initiatives in the country, particularly in West Bengal, Bihar, Jharkhand and the Northeastern States;
- (b) the steps taken by the Government to mitigate the imbalance of regional disparities in the implementation and effectiveness of skill development across the country which further exacerbates the challenges faced by job seekers in certain regions; and
- (c) the details of the placement status in terms of skilled trainees during the last three years, State-wise and sector-wise?

STATEMENT REFERRED TO IN REPLY TO PARTS (A) TO (C) OF LOK SABHA STARRED QUESTION NO.*259 TO BE ANSWERED ON 07.08.2023 ASKED BY SHRIMATI SAJDA AHMED REGARDING SKILL DEVELOPMENT TRAINING.

(a) The Skill India Mission (SIM) of the Government of India is aimed at skilling, reskilling and up-skilling to ensure our youth are prepared for the large number of opportunities coming up as the economy expands and India moves from the 10th largest economy to 3rd largest economy in the world. SIM is aimed at future ready and Industry ready talent among the youths.

Under the SIM, the Ministry of Skill Development and Entrepreneurship (MSDE) provides skill, re-skill and up-skill training to youth through a comprehensive network of skill development centres/institutes under various schemes viz. Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Sikhshan Sansthan (JSS), National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS) through Industrial Training Institutes (ITIs) across the country including West Bengal, Bihar, Jharkhand and the North Eastern States. The State/UT-wise number of persons trained under these schemes including in West Bengal, Bihar, Jharkhand and the North Eastern States are placed at **Annexure-I**.

Apart from above, more than 20 Central Ministries are implementing Skilling/upskilling training programmes through various schemes, such as Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY), the Rural Self Employment Training Institutes (RSETI) under Ministry of Rural Development, Deen Dayal Antyodaya Yojana – National Urban Livelihood Mission (NULM) under Ministry of Housing and Urban Affairs etc.

(b) To synergize initiatives of skill development in the country and overcome the regional imbalance, the schemes of MSDE focus on implementation of training interventions with increased participation of states and districts through State Skill Development Mission (SSDMs) and District Skill Committees (DSCs). DSCs are mandated with formulating District Skill Development Plans (DSDPs) to promote decentralized planning and implementation at the grassroots. The DSDPs identify sectors in which employment opportunities and demand for skilling exists in the district. Skill gap studies conducted through reputed organizations also provide information on the skills needed and the skill gaps in various sectors, which help to understand the skill requirements and opportunities. Skill Development Programmes of the Government are designed and implemented to bridge identified skill gaps across sectors.

Further, to encourage training in Special Areas, which includes North Eastern States, Hilly States and Districts affected by Left Wing Extremism, special provisions in Costing Norms for training have been made. This includes an additional 10% over and above the Base Cost, for training programmes conducted in these areas, support for boarding and lodging for trainees from Special Areas undergoing training outside these special areas and to and fro transport cost for candidates from Special Areas undergoing training outside Special Areas. Government is also providing financial assistance for setting up and upgradation of Industrial Training Institutes (ITIs) through its schemes i.e. Enhancing Skill Development Infrastructure in North Eastern States and Skill Development in 48 Districts affected by Left Wing Extremism (LWE).

(c) Amongst the schemes of the MSDE, placement is specifically tracked only under Short Term Training (STT) component of PMKVY. Since the beginning of the Scheme in 2015-16, under the STT component of PMKVY, a total 68.94 lakh candidates have been trained as on 31.03.2023, out of which 54.43 lakh have been certified and 24.37 lakh candidates have been reported placed.

The State-wise number of trainees reported placed and sector-wise number of trainees reported placed for the last three years under PMKVY are at **Annexure- II and III respectively.**

As regards other schemes, third party evaluation reports have observed success in terms of placement or enhancement of income of candidates trained. As far as employment of the JSS scheme beneficiaries is concerned, third party evaluation report of the scheme observed that as an impact of the training programme conducted at JSSs, the self and wage employment and private job have become evident. The report has further observed that usefulness of the scheme would be further evident from the fact that 77.05% of the beneficiary trainees have undergone occupational shifts. The final report of Tracer Study of ITI Graduates (published in January 2018 by the Ministry of Skill Development & Entrepreneurship, GoI) mentions that 63.5% of total ITI pass-outs got employed (wage + self, out of which 6.7% are self-employed).
