## STATEMENT REFERRED TO IN REPLY OF LOK SABHA QUESTION NO. \*262 PART (a) TO (f) FOR ANSWER ON 08.08.2023 ASKED BY SHRI RAHUL RAMESH SHEWALE AND SHRI CHANDRA SEKHAR SAHU REGARDING "SHORTAGE OF VETERINARY DOCTORS"

- a) As compiled by the Veterinary Council of India (VCI), there are 81,938 Registered Veterinary Practitioners as on 31.03.2023 in the country. There are 10,570 Registered Veterinary Practitioners in Maharashtra and 2,791 Registered Veterinary Practitioners in Odisha. The State/UT-wise list is placed at Annexure-I.
- b) Animal Husbandry is State subject and the staffing of government hospitals is done by the States depending on their requirement based on disease epidemiology and animal profile. As per the information received from the States there is varying percentage of shortage of veterinary doctors in some states, while others have no shortage.
- c) The State/UT-wise list is placed at Annexure-I.
- d) and (e) Animal Husbandry is State subject and while some states have reported adequate number of Veterinary Doctors, others have reported taking actions like creation of new posts and filling up of vacant posts to augment the capacity.
- f) The question does not arise.
