- (b) if so, the details thereof;
- (c) the names of the places in various States of the country where the time limit of SEZs has been extended during the last three years;
- (d) whether any concession on tax or other incentives has been provided; and
- (e) if so, the details thereof?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (e) OF LOK SABHA STARRED QUESTION NO. 87 FOR ANSWER ON 26TH JULY, 2023 REGARDING SEZs

- (a) to (c): In terms of Rule 6(2)(a) of the Special Economic Zones Rules, 2006, the letter of approval granted to a SEZ developer is valid for a period of three years within which time effective steps are to be taken by the developer to implement the approved proposal. The Board of Approval (BoA) under Department of Commerce may, on an application by the developer and on recommendation of Jurisdictional Development Commissioner, extend the validity period of the letter of approval for one year at a time. BoA has granted extension of validity period to 53 developers of SEZs across the country during the last three years and current year as detailed at **Annexure**.
- (d) and (e): The tax exemptions and other incentives allowed to SEZs are stipulated under Section 7 and 26 of the SEZs Act, 2005, these includes:
 - i. Exemption from customs/excise duties for development of SEZs for authorized operations approved by the BOA.
 - ii. Zero rating of IGST on domestic procurement of goods and services for authorised operation.
 - iii. Exemption from any duty of excise, under the Central Excise Act, 1944 or goods supplied from Domestic Tariff Area (DTA) to carry on authorised operation.

The other incentives allowed to SEZ Developers are as follows.

- i. Single window clearance for Central and State level approvals.
- ii. Presence of dedicated Customs Officers to facilitate clearance of goods.
- iii. SEZ units are allowed to deal with restricted/prohibited goods as per provision of SEZ law.
