- (a) the state-wise details of the textile parks proposed to be set up under the Scheme for Integrated Textile Parks (SITPs) including in Odisha and Maharashtra;
- (b) the status of completion of the proposed textiles parks under SITPs;
- (c) the details of the funds allocated, sanctioned and released for the textile parks under SITPs;
- (d) whether the Government has taken any steps to ensure timely completion of the textile parks and prevent delays and cost overruns;
- (e) if so, the details thereof and if not, the reasons therefor; and
- (f) the steps taken by the Government to set up more Mega Textile Parks under SITPs to generate employment opportunities?

**(a) & (b):** The Scheme for Integrated Textile Park (SITP) was introduced in 2005-06 to provide the textile industry with state of art infrastructure for setting up of textile units. The scheme was in implementation till 31.03.2021 after which it was approved for continuation from 2021-22 to 2025-26 for meeting committed liabilities only. 24 parks are under implementation under the scheme as at present. A list of parks currently under implementation including those in Maharashtra are given at Annexure. No park is currently proposed/under implementation in Odisha.

**(c):** From 2006-07 to 2021-22, Rs. 1,840 crores were allocated under the scheme, out of which Rs. 1,759 crore have been released. As SITP was subsumed under Textile Cluster Development Scheme (TCDS) as a subcomponent, no component -wise fund was allocated for the scheme in 2022-23 and 2023-24.

**(d) & (e):** The Project Approval Committee (PAC) under SITP regularly reviews progress of the parks in order to ensure speedy implementation. Concerned State Governments are also invited in PAC meetings to review the progress of project and remove bottlenecks if any.

**(f):** Under the PM MITRA Scheme, Government has recently approved setting up of 7 (Seven) PM Mega Integrated Textile Region and Apparel (PM MITRA) Parks in Greenfield/Brownfield sites with world class infrastructure including plug and play facility with an outlay of Rs. 4,445 cr for a period of seven years upto 2027-28.
