Will the Minister of ROAD TRANSPORT AND HIGHWAYS

be pleased to state:

- (a) whether, as per Infrastructure and Project Monitoring Division (IPMD) report, Road Transport and Highways Sector has the maximum number of delayed projects;
- (b) if so, the details thereof, project/State-wise, particularly in Tamil Nadu;
- (c) whether there is cost overrun in the implementation of these projects due to the delay in the process;
- (d) if so, the details thereof, project-wise along with the reasons therefor; and
- (e) the measures being taken by the Government to ensure timely completion of delayed and ongoing projects and minimize cost overruns on road transport and highways sector projects in the country?

ANSWER

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS

(a) to (d) As on 30th June, 2023, 1612 projects are under construction across the country including in the state of Tamil Nadu, of which 674 projects are behind the original schedule, due to various reasons. State-wise details are at Annexure.

All delayed projects do not face cost escalation. Price escalation is payable as per contract conditions, and actual amount of price escalation and increase in project cost, if any, is known only on actual completion of project and final settlement of bills. However, if delay is attributable to the Contractor, damages are imposed and price escalation is not paid, and there is in no additional cost due to delay.

(e) The Ministry actively monitors NH projects in close coordination with project implementing agencies, State Governments, contractors/developers. Periodic review meetings are held at various levels, and several steps have been taken to improve liquidity of funds available with contractors/developers, to expedite progress. In addition, the Ministry has taken many initiatives to avoid or reduce project delays, including streamlining land acquisition & environment clearances, online approval of GAD of Railway ROBs/RUBs, revamping dispute resolution mechanism, premium rescheduling, one-time fund infusion, etc.
