Will the Minister of Housing & Urban Affairs be pleased to state:

- (a) whether the Union Government has implemented Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM) in the country, State/UT-wise including in Bihar and Andhra Pradesh;
- (b) if so, the details thereof including the number of beneficiaries under this scheme in the State of Bihar and Andhra Pradesh during last three years, district-wise;
- (c) the details of funds released by the Government under the scheme to the State of Bihar and Andhra Pradesh during last three years and the current year, district-wise; and
- (d) the timelines, targets and accomplishments made so far under the scheme?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

(a) & (b) : Ministry of Housing and Urban Affairs is implementing a Centrally Sponsored Scheme namely "Deendayal Antyodaya Yojana – National Urban Livelihoods Mission (DAY-NULM)", in the statutory towns of the country, including Andhra Pradesh and Bihar. The details of beneficiaries during the last three years for the State of Andhra Pradesh and Bihar is at Annexure-I. However, district-wise details of physical progress under the scheme is not maintained at the Central level. (c):Funds under DAY-NULM are released to States/ UTs for all its components as a whole. Inter-se allocation of funds for different components is made by States/ UTs. District-wise fund is not maintained at Central level. Details of Central Share fund released under DAY-NULM to the State of Andhra Pradesh and Bihar during last three years and the current year {i.e. 2020-21 to 2023-24 (upto 30.06.2023)} is as under:-
