Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the number of projects executed by National Building Construction Corporation (NBCC) Limited during the last twenty years along with the details of projects where properties have not been allotted to allottees yet;
- (b) whether Completion Certificate and registry of NBCC Plaza in Pushp Vihar, Delhi are pending since more than fifteen years and if so, the details thereof;
- (c) whether NBCC Ltd. has handed over the maintenance of the NBCC Plaza Complex in Pushp Vihar, Delhi to the allottees and if not, the reasons therefor; and
- (d) whether application of NBCC Services Ltd. for fire safety certificate for NBCC Plaza Complex in Pushp Vihar, Delhi was rejected in the month of January 2023 and if so, the reasons therefor?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

- (a) Details of projects executed by National Buildings Construction Corporation Limited (NBCC) and their status are at annexure.
- (b) NBCC completed the project in the year 2007 and the occupancy certificate was issued by local body for the Project on 29.03.2011. However, completion certificate is pending because of the issues between NBCC and local bodies with regard to additional FAR charges.
- (c) NBCC has not handed over the maintenance of the NBCC Plaza, Pushp Vihar, Delhi to its allottees as it has not received any request to form Resident Welfare Association (RWA) for NBCC PLAZA from its allottees.
- (d) No Sir. It was not rejected. Fire authority has issued fire safety certificate dated 28.04.2023 for a period of 3 years.
