- (c) whether there has been any delay in release of the allocated funds and if so, the reasons therefor;
- (d) the details of work done for Hydrocarbon Exploration in the State of Maharashtra; and
- (e) whether the Government has any plans/proposals/ongoing projects for Hydrocarbon Exploration and if so, the details thereof, State-wise?

- (a) to (c): Hydrocarbon exploration is a continuous activity that *inter-alia*comprises seismic data acquisition, processing, interpretation, well drilling and other exploration activities (like Airborne Gravity Gradiometry, etc.). The survey projects which were funded by the Government of India and fund utilized for the same are annexed as **Annexure**. There has been no delay in releasing the funds.
- (d):Under the National Seismic Programme, 9696.25-linekilometers (LKM) of 2D Seismic Acquisition, Processing and Interpretation (API) data has been acquired in the State of Maharashtra. One Block with part area of 1552.94 Sq. KM falling in the State of Maharashtra has been allocated to Oil and Natural Gas Corporation Ltd.(ONGC).
- (e): Hydrocarbon exploration is a continuous process. Government has awarded several blocks in various States in which exploratory activities such as seismic data acquisition, processing, interpretation and drilling of exploratory wells are being undertaken.
