- (a) The details of Jal Shakti Kendras in the country, State/UT-wise are at **Annexure I** and district-wise details of Jal Shakti Kendras in the state of Haryana including Sonipat Parliamentary Constituency are at **Annexure II**.
- (b) Water is a State subject and the Central Government supplements the efforts of the States through technical and financial support. An advisory has been issued to all States/UTs on setting up of JSKs prescribing objectives, indicative template, human resources etc. JSK acts as a knowledge centre for disseminating information related to any water related issue such as water conservation methods, water use efficiency, policies on ground water, efficient irrigation techniques, water quality, grey water management etc. and a technical guidance centre to advice local people on these matters. A list of documents has been proposed in the aforesaid advisory to be kept on relevant Central and State legislations, rules, directives, manuals etc. in the JSK.
- (c) The State Government has informed that Jal Shakti Kendras have been established in all 22 districts of Haryana.
