- (a) the focus routes under Krishi-UDAN scheme in the State of Andhra Pradesh;
- (b) the number of flights operated and cargo handled (in tonnes) route/airport-wise across all routes in the country during the years FY 2020-21 and FY 2021-22;
- (c) the number of flights operated and cargo handled (in tonnes) in the Vizag - Far East route in FY 2020-21 and FY 2021-22; and
- (d) the details of new routes being included under the Krishi-UDAN scheme?

ANSWER

Minister of State in the Ministry of CIVIL AVIATION (GEN. (DR) V. K. SINGH (RETD))

- (a) Vizag Airport in Andhra Pradesh is included under the Krishi Udan Scheme with a focus on Far East for transporting seafood.
- (b) Airport wise Domestic & International Air Cargo flights and tonnage handled in Financial Years 2020-21 and 2021-22 across all routes in the country is enclosed as Annexure.
- (c) Details of flights operated and tonnage handled at Vizag airport to the Far East region via Kolkata airport is hereunder:

No. of flights operated 905 618 Cargo handled (in MT) 596 352;

(d) Krishi Udan is an ongoing Scheme and is reviewed from time to time in consultation with stakeholders. Initially, 53 Airports were

covered in the Krishi Udan Scheme. After evaluation of the scheme, five more airports viz. Belagavi, Bhopal, Darbhanga, Jabalpur and Jharsuguda have been included, making it 58 airports under Krishi Udan.
