(a) whether the Government and private players have inked joint venture projects in defence sector, if so, the details thereof;

(b) the ratio of the shareholding of Government and private undertakings in the defence sector during the last five years and the current year, year-wise;

(c) whether the Government has liquidated its shares in Defence PSUs during the last five years, if so, the details thereof;

(d) the reasons for the sudden increase of private/corporate shareholdings and decrease in Government holdings in Defence PSUs during the last five years; and

(e) the details of the private sector participation in the defence corridor projects in the country, State/ UT-wise including Tamil Nadu?

In addition to above, 7 New Defence Public Sector Undertakings have been incorporated on 1st October, 2021 as 100% Government Owned Defence Public Sector Undertakings which have been formed out of 41 erstwhile Ordnance Factories under Ordnance Factories Board. These 7 New Defence Public Sector Undertakings are Advanced Weapons and Equipment India Limited (AWEIL), Gliders India Limited (GIL), Troop Comforts Limited (TCL), Armoured Vehicles Nigam Limited (AVNL), Munitions India Limited (MIL), Yantra India Limited (YIL) and India Optel Limited (IOL).

Shareholding of Government in all the DPSUs in current year is same as that of year 2022-23.

(c): During the last five years, Government has not completely liquidated its shareholding in any of the DPSUs. However, Government has reduced shareholding in four DPSUs. i.e. Hindustan Aeronautics Limited, Bharat Electronics Limited, Bharat Dynamics Limited and Mazagon Dock Shipbuilders Limited as per the details given in part (a) above.

(d): Shareholding in DPSUs is primarily reduced to comply with the minimum public shareholding norms required under the provisions of the securities (Contract) regulation Act 1956 during the financial year 2020-21 and disinvestment policy of the Government.
