- (a) the number of unorganised workers eligible for e-Shram registration in West Bengal and Maharashtra;**
- (b) the number of eligible unorganised workers for e-Shram registration, district-wise especially for Uttar Dinapur District;**
- (c) the actual number of e-Shram registration done in West Bengal and Maharashtra, district-wise including Uttar Dinapur District;**
- (d) the number of e-Shram registered persons who have also registered under Pradhan Mantri Shram Yogi Maan-Dhan Yojana and NPS-Traders Pension Scheme; and**
- (e) the number of Maan-Dhan registered workers and NPS-Pension registered persons, district-wise especially in Uttar Dinapur District?**

(a) to (e): Ministry of Labour & Employment launched eShram portal on 26th August 2021 for creation of a comprehensive National Database of Unorganised Workers, seeded and authenticated with Aadhaar. As on 25th July 2023, over 28.97 crore unorganised workers have already registered on eShram portal.

The targets for registration in eShram have been estimated at State level. The estimated target for eShram registration in West Bengal and Maharashtra are 2.79 Crore & 3.45 Crore respectively.

District wise number of unorganised workers registered on eShram belonging to West Bengal (including Uttar Dinajpur District) and Maharashtra State is at Annexure-I and Annexure-II respectively.

As on 24th July, 2023 the number of eShram registered persons who also registered under Pradhan Mantri Shram Yogi Maandhan Yojana is 1,77,777 and NPS-Traders Pension Scheme is 4761.

The district-wise number of Maan-Dhan registered workers and NPS-Traders registered persons of West Bengal including Uttar Dinajpur District is at Annexure-III.
