TOURISM PROJECTS FOR DEVELOPMENT OF TOURISM IN BIHAR

- (a) the details of the projects for development of tourism approved, sanctioned and executed in Bihar during the last three years including the current year, year-wise;
- (b) the details of the tourism projects completed so far and the time by which the remaining projects are likely to be completed;
- (c) the reasons for the delay in completion of the pending projects;
- (d) the details of funds allocated, released and utilized for the development of tourism sector in the State during the said period, year-wise; and
- (e) whether the State Government of Bihar has submitted any proposal to the Government and if so, the details thereof along with the present status of ongoing projects in the State of Bihar?

(a) to (e): The Ministry of Tourism under the Schemes of "Swadesh Darshan", "National Mission on Pilgrimage Rejuvenation and Spiritual Heritage Augmentation Drive (PRASHAD)" and 'Assistance to Central Agencies for Tourism Infrastructure Development' provides financial assistance to State Governments/Union Territory Administrations/Central Agencies for the development of tourism related infrastructure and facilities at various tourism destinations in the country including Bihar.

The details of projects sanctioned, amount released and amount utilized along with their status in the State of Bihar under the Swadesh Darshan, PRASHAD and Assistance to Central Agencies Schemes is given at Annexure. The projects sanctioned under the above schemes are under various stages of implementation for more footfalls to these tourism destinations/sites.

Receiving proposals from the State Governments/UT Administrations/Central Agencies for financial assistance for tourism projects is a continuous process. The proposals received are examined with reference to the prescribed guidelines and financial assistance is extended for such projects subject to fulfilment of the stipulated conditions, operational viability and availability of funds.
