- (b) the budgetary allocation and expenditure for setting up / improvement of Industrial Training Institute (ITI) across the country, State-wise;
- (c) whether it is likely to be funded centrally or to be contributed by the States also; if not, the details thereof; and the reasons therefor;
- (d) whether the allocation of funds to the State Government have been delayed, if so, the details thereof and the reasons therefor;
- (e) whether any discrepancies shortcomings have been found in procurement of equipments/ machines in said ITIs, and if so, the details of the action taken against people/ institutes violating the rules?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(SHRI RAJEEV CHANDRASEKHAR)

- (a) The Directorate General of Training (DGT) under the Ministry of Skill Development & Entrepreneurship (MSDE) is responsible for providing the broad Policy Framework for running the long-term skilling ecosystem in the country. The financial and administrative management of the Industrial Training Institutes (ITIs) lies with the State Governments. Accordingly, the budgetary allocation and expenditure for setting up/improvement of ITIs is the domain of respective State Governments/UT Administration. However, DGT under MSDE, has allocated funds under following schemes for establishment and improvement of ITI infrastructure across the country.
- i) Skills Strengthening for Industrial value Enhancement (STRIVE) programme is a World Bank assisted project with the objective of improving the relevance and efficiency of skills training provided through ITIs and apprenticeships. The financial agreement was signed between the Government of India and the World Bank in December 2017 with a budget outlay of INR 2200 Crore (US \$ 318 million), covering 500 ITIs, consisting of both Government and private ITIs, as well

as 100 Industry Clusters (ICs). The details of state wise allocation and fund released for upgradation of ITIs are at *Annexure I*.

- ii) Enhancing Skill Development Infrastructure in North Eastern States: The scheme is for upgradation of 22 existing ITIs by establishment of 3 new trades in each ITI; supplementing deficient infrastructure in 28 ITIs by constructing new boundary wall, new hostel along with supplementing old and obsolete tools and equipment for 3 existing trades in each ITI; and establishment of 34 new ITIs. The details of state wise allocation and fund released are at *Annexure I*.
- iii) **Skill Development in 48 Districts Affected by LWE**: The scheme inter-alia supports establishment of 48 ITI in 48 districts affected by Left Wing Extremism (LWE). The details of state wise allocation and fund released are at *Annexure I*.
- iv) **Upgradation of existing Government ITIs into Model ITIs:** At least one existing ITI in each State has been taken up for upgradation into Model ITI for showcasing best practices, efficient and high quality training delivery and sustainable and effective industry relationship. The details of state wise allocation and fund released are at *Annexure I*.
- (b) STRIVE is Central Sector Scheme and therefore there is no state share. However, under the schemes for Enhancing Skill Development Infrastructure in North Eastern States, Skill Development in 48 Districts Affected by LWE and Upgradation of existing Government ITIs into Model ITIs expenditure is shared between the Central and State Government.
- (c) The funds are released to the State Governments without delay upon submission of Utilization Certificates (UCs) and satisfactory progress reports as per guidelines of scheme.
- (d) The procurement of tools and equipment is done by respective States/UTs. No discrepancies/shortcomings have been reported by States/UTs in procurement of equipment/ machines in ITIs covered under the scheme.
