UPLIFTMENT OF TRIBALS

1720. SHRI RAJESHBHAI CHUDASAMA:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

(a) whether the Government has many schemes and programmes for the tribal people of the country in different States, and whether it has helped in economic upliftment of tribals, if so, the details thereof;

(b) the impact of the different schemes and programmes for economic upliftment of the tribal people; and

(c) the number of tribal people, both men andwomen, who are getting benefits from these schemes and programmes, State-wise?

ANSWER

MINISTER OF STATE FOR TRIBAL AFFAIRS (SMT. RENUKA SINGH SARUTA)

(a) to (c): Ministry of Tribal Affairs is implementing following schemes/programmes for economic upliftment of Scheduled Tribes (STs) in the country:

(1) Ministry is implementing the scheme '**Pradhan Mantri Janjatiya Vikas Mission** (**PMJVM**)' with a total financial outlay of Rs. 1612.27 crore for implementation during the financial years 2021-22 to 2025-26. PMJVM has been redesigned through merger and extension of two existing schemes for promotion of tribal livelihood, i.e., "Mechanism for Marketing of Minor Forest Produce (MFP) through Minimum Support Price (MSP) and Development of Value Chain for MFP" and "Institutional Support for Development and Marketing of Tribal Products / Produce". Tribal Cooperative Marketing Development Federation of India (TRIFED) is the nodal agency for implementation of the Scheme. PMJVM envisions to strengthen tribal entrepreneurship initiatives and to facilitate livelihood opportunities by promoting more efficient, equitable, self-managed, optimum use of natural resources, Agri / Non-Timber Forest Products (NTFPs) / Non-farm enterprises. The Mission seeks to support the theme of "Vocal for Local by Tribal".

(2) Marketing and Logistics Development for Promoting Tribal Products from North - EasternRegion - The scheme has been approved during 2021-22 for two years which aims to strengthen livelihood opportunities for tribal artisans through increased efficiency in

procurement, logistics and marketing of tribal products. The scheme has been specifically designed for the North Eastern Region of India.

(3) Venture Capital Funds for STs - The scheme has been approved during 2021-22 and aims topromote entrepreneurship among the Scheduled Tribes and to provide concessional finance tothem. The VCF-ST scheme would be a social sector initiative to promote ST entrepreneurship and to support and incubate the start-up ideas by ST youth. The scheme would be managed by the agency having expertise and experience.

(4) National Scheduled Tribes Finance and Development Corporation (NSTFDC), under the Ministry of Tribal Affairs is an apex organisation set up exclusively for economic development of Scheduled Tribes. The Corporation provides financial assistance for income generation activities and marketing support assistance for economic upliftment of Scheduled Tribes all over the country under the following schemes:

- Term Loan Scheme: NSTFDC provides Term Loan for viable projects costing upto ₹50.00 lakh per unit. Under the scheme, financial assistance is extended upto 90% of the cost of the project and the balance is met by way of subsidy / promoter contribution / margin money.
- Adivasi Mahila Sashaktikaran Yojana (AMSY): This is an exclusive scheme for economic development of Scheduled Tribes women. Under the scheme, NSTFDC, provides loan upto 90% for projects costing upto ₹2.00 lakh. Financial assistance under the scheme is extended at highly concessional rate of interest of 4% per annum.
- Micro Credit Scheme for Self Help Groups (MCF): This is an exclusive scheme for Self Help Groups for meeting small loan requirement of ST members. Under the scheme, the Corporation provides loans upto ₹50,000/- per member and maximum ₹ 5 Lakh per Self Help Group (SHG).
- Adivasi Shiksha Rrinn Yojana (ASRY): This is an education loan scheme to enable the ST students to meet expenditure for pursuing technical and professional education including Ph.D. in India. Under this scheme, the Corporation provides financial assistance upto ₹10.00 lakh per eligible family at concessional rate of interest of 6% per annum.

Ministry of Tribal Affairs also provides funds to the State Governments based on their proposals for economic upliftment of tribals by undertaking various livelihood activities including agriculture, horticulture, animal husbandry, fisheries and other non-farm-based livelihood activities etc. under the schemes/programmes 'Development of Particularly Vulnerable Tribal Groups (PVTGs)' and 'Grants under Article 275(1) of the Constitution'.

Apart from the above, Government has also been implementing several schemes/programmes aimed at improving economic condition of people including tribals

like Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), Pradhan Mantri Awaas Yojana- Gramin (PMAY-G), Deendayal Antyodaya Yojana-National Rural Livelihoods Mission (DAY-NRLM), National Social Assistance Programme (NSAP) of Ministry of Rural Development, Formation and Promotion of10,000 FPOs, PM-KISAN, Agriculture Infrastructure Fund, Crop Insurance Scheme, Rashtriya Krishi Vikas Yojana of Ministry of Agriculture and Farmers' Welfare, National LivestockMission and Dairy Development of Department of Animal Husbandry and Dairying, Pradhan Mantri Matsya Sampada Yojana of Department of Fisheries, Pradhan Mantri Kisan Sampada Yojana and Prime Ministry Formalization of Micro Food Processing Enterprises Scheme of Ministry of Food Processing Industries, Atma Nirbhar Bharat Rozgar Yojana of Ministry of Micro, Small & MediumEnterprises, Pradhan Mantri Kaushal Vikas Yojana of Ministry of Skill Development & Entrepreneurship, National Handicraft Development Programme of Ministry of Skill Development Mantri Jan-Dhan Yojana (PMJDY), Atal Pension Yojana (APY), Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) etc.

NITI Aayog has published a report "National Multidimensional Poverty Index" in July 2023 which concludes that 13.5 crore people moved out of multidimensional poverty between 2015-16 and 2019-21. Though the report does not explicitly mention about STs, district –wise data reveals that almost all the tribal priority districts have shown an improvement in multidimensional poverty.
