(a) to (d) Under Skill India Mission, Ministry of Skill Development and Entrepreneurship (MSDE) delivers skill training through various schemes viz. Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Sikhshan Sansthan (JSS), National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS) through Industrial Training Institutes (ITIs), to all the sections of the society across the country including the State of Bihar and Gopalganj District. The number of persons trained under these schemes in the State of Bihar including district of Gopalganj and Grants released for Bihar is as under:
