Will the Minister of Skill Development and Entrepreneurship be pleased to state:

(a) whether the Government is planning to open additional centres for the Crafts Instructor Training Scheme (CITS) in Uttar Pradesh, Madhya Pradesh and Maharashtra to meet the growing demand of skilled craftsmen in the States;

(b) whether the Government has identified specific locations or regions in Uttar Pradesh, Madhya Pradesh and Maharashtra having a high concentration of craftsmen and would benefit from the establishment of new CITS centres;

(c) whether the Government is focusing on local crafts of the States of Uttar Pradesh, Madhya Pradesh and Maharashtra; and

(d) the details and number of people enrolled in the scheme in Uttar Pradesh, Madhya Pradesh and Maharashtra since inception?

ANSWER

MINISTER OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(a) and (b) : Directorate General of Training (DGT) under Ministry of Skill Development & Entrepreneurship is implementing 'Craft Instructor Training Scheme', through a network of 33 National Skill Training Institutes (NSTIs) and 76 Institutes for Training of Trainers (IToTs) (65 State Govt. & 11 Private) across the country including in the States of Uttar Pradesh, Madhya Pradesh and Maharashtra. List of existing NSTIs & IToTs in the States of Uttar Pradesh (5), Madhya Pradesh (2) and Maharashtra (2) is at **Annexure-I**. In addition, State Governments are allowed to start regular courses under CITS as well as courses for the candidates under 'Recognition of Prior Learning'(RPL) in the Model / Nodal ITIs by converting their existing Govt. ITIs into Institute for Training of Trainers (IToTs). In the year 2022, a total of 15 'Institutes for Training for Trainers' have been affiliated in the States of Uttar Pradesh (6), Madhya Pradesh (1) and Maharashtra (8), the list of IToTs is at **Annexure-II**.

(c & d) MSDE implements schemes for skill development through training centres spread across the Country including in the States of Uttar Pradesh, Madhya Pradesh and Maharashtra. Training is imparted in various trades including in local / traditional crafts. Scheme-wise details imparting training in local crafts/traditional courses are given below:

(i) Craftsmen Training Scheme (CTS): DGT conducts NSQF compliant courses through a network of Industrial Training Institutes (ITIs) under Craftsmen Training Scheme (CTS), which includes courses to promote the local crafts / traditional sector job roles across the country including States of Uttar Pradesh, Madhya Pradesh and Maharashtra. Number of ITIs running these courses is at **Annexure-III**.

(ii) Jan Shikshan Sansthan (JSS): Directorate of JSS under MSDE creates on-ground awareness about the courses offered under the scheme, counsels the beneficiaries concerning their areas of interest, and undertakes skill training programmes through JSSs. Training programmes offered in the JSS Scheme include local traditional skills i.e. Assistant Hand Embroider - (Phulkari / Chickankari / Kashmiri / Zari Zardozi / Kantha), Assistant Artisan- Bamboo Craft, Assistant-Jute Craft Product Maker, Assistant Carpet Weaver- Knotted are also promoted. Details are given at **Annexure-IV**.

(iii) Pradhan Mantri Kaushal Vikas Yojana: Under Skill India Mission, Ministry of Skill Development and Entrepreneurship is implementing a flagship scheme Pradhan Mantri Kaushal Vikas Yojana (PMKVY) to impart skill development training to youth of the country including artisans and craftsmen. Under PMKVY, training has been imparted in various job roles including job roles of traditional arts and crafts. Details of training under PMKVY in Handicrafts and Carpet Sector in Uttar Pradesh, Madhya Pradesh and Maharashtra as on 30-Jun-23 is attached at **Annexure-V**.
