TRAINING UNDER SKILL INDIA PROGRAMME

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the number of the youth trained under various schemes and provided employment in the country so far, State-wise and district-wise;
- (b) the details of special arrangements made for the youth of North-Eastern States for this purpose;
- (c) the details of companies which provided employment to the trained youth of Assam and North-Eastern States, State-wise;
- (d) whether the trained youth received employment abroad also and if so, the details thereof; and
- (e) the sectors in which Skill India Programme is being implemented along with the names and details of the sectors?

ANSWER

MINISTER OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

- (a) Under Skill India Mission, Ministry of Skill Development and Entrepreneurship (MSDE) delivers skill training through various schemes viz. Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Sikhshan Sansthan (JSS), National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS) through Industrial Training Institutes (ITIs), to all the sections of the society across the country including the North-Eastern States. Amongst the schemes of the MSDE, only in the case of the STT component of PMKVY, placement is specifically tracked. The District-wise number of youth trained and reported placed under PMKVY is at **Annexure-I** and the district-wise number of youth trained under JSS, NAPS and CTS is at **Annexure-III**, **Annexure-III** and **Annexure-IV** respectively.
- (b) With a view to encourage and assist training in North-East States, special provisions for promotion of skill development have been provided as per details below:
- (i) Transport Cost- For candidates from Special Areas, such as North Eastern States who are undergoing training outside of such Special Areas, to and fro transport cost as per actuals, subject to a maximum of Rs. 5000/- per trainee, is payable.
- (ii) Over and above the Base Cost, an additional amount equal to 10% of the Base Cost is permitted for Skill Development programmes conducted in the North Eastern States.
- (iii) To enable the newly skilled persons from North-East to settle into their jobs/vocations under wage employment, post placement support would be provided directly to the candidate at the rate of Rs. 1500/- per month for the following durations:

Post Placement Support @ Rs. 1500/- per month	Men	Women
Placement within District of domicile	1 Month	2 Months
Placement outside District of domicile	2 Months	3 Months

- (c) State-wise list of employers who employed PMKVY trainees is at **Annexure-V**.
- (d) As there are multiple avenues through which skilled personnel can seek employment in foreign destinations including the countries with which MSDE has engaged bilaterally. MSDE monitors the mobility of skilled personnel from India under the bilateral employment and internship cooperation programmes that exists at Government to Government(G2G) level and Business to Business (B2B) level with select few countries. Under such arrangements, a total of 23,127 candidates have got job opportunities in foreign countries from 1.04.2022 to 30.06.2023.
- (e) Under PMKVY, the skill training is being given in 37 broad sectors, in JSS, 11 sectors and in CTS, 33 Sectors. The names of these sectors are given in **Annexure VII**, **Annexure VII** and **Annexure VIII** respectively.
