(a) to (c): The Ministry of Tourism under the Schemes of "Swadesh Darshan", "National Mission on Pilgrimage Rejuvenation and Spiritual Heritage Augmentation Drive (PRASHAD)" and 'Assistance to Central Agencies for Tourism Infrastructure Development' provides financial assistance to State Governments/Union Territory (UT) Administrations/Central Agencies for the development of tourism related infrastructure and facilities at various tourism destinations in the country including Bihar.

Further, financial assistance has also been provided to the State Governments/UTs including Bihar for organizing fairs/festivals & tourism related events under Domestic Promotion & Publicity including Hospitality (DPPH) Scheme.
