THEFT OF IDOLS

1798. SHRIMATI KANIMOZHI KARUNANIDHI

Will the Minister of CULTURE be pleased to state:-

- (a) the details regarding the number of temple idols stolen and recovered so far in the country, State-wise including Tamil Nadu during the last 10 years;
- (b) the measures taken by the Government to prevent idol theft in temples;
- (c) the details regarding the number of idols stolen and still not recovered from foreign countries, country-wise; and
- (d) the measures taken by the Government to recover the stolen idols from abroad?

ANSWER

THE MINISTER OF CULTURE, TOURISM AND DEVELOPMENT OF NORTH EASTERN REGION (SHRI G. KISHAN REDDY)

- (a) The list of antiquities stolen and recovered from the Centrally Protected Monuments, sites, temples, etc. during last 10 years (2013-2023) is annexed as Annexure-I.
- (b) Archaeological Survey of India is committed towards the protection of monuments, sites and antiquities under its jurisdiction. Besides regular watch and ward staff of Archaeological Survey of India, Private Security Guards, State Police Armed Guards, and Central Industrial Security Force have been deployed as per requirement. Whenever any theft of antiquity is reported, FIR is lodged in concerned police station and 'Look Out Notice' is issued to law enforcement agencies including Custom Exit Channels to keep vigil to trace stolen antiquity and prevent its illegal export.
- (c) Total 31 antiquities have been stolen from the Centrally Protected Monuments, sites, temple, etc. as mentioned Annexure-I, of which 27 are still to be recovered. However, no information is available about their illegal shipping abroad.
- (d) Government is committed to bring back the antiquities of Indian origin which were taken away from India. Whenever any such antiquity of Indian origin surfaces abroad, Archaeological Survey of India takes up the matter with the Indian Embassies/Missions abroad through MEA for their retrieval. Archaeological Survey of India has retrieved 251 antiquities from foreign countries from the year 1976 to 2023, of which 238 have been retrieved from 2014 to 2023.
