1805. SHRIMATI SAJDA AHMED:

Will the Minister of TOURISM be pleased to state:

- (a) whether the Government has taken any initiatives to develop agrifarm tourism spots across the country to attract tourists for farm life experiences;**
- (b) if so, the details of these initiatives;**
- (c) the details of the initiatives taken by the Government to promote tourism in Panchayat areas; and**
- (d) the details of the tourism development projects undertaken in the country during the last three years, both in rural and urban areas?**

ANSWER

THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a) to (c): Promotion and development of Tourism is primarily the responsibility of the State Governments/UT Administrations.

However, Ministry of Tourism promotes India in a holistic manner. As part of its on-going activities, it releases global print, electronic and online media campaigns in important and potential markets overseas, under the 'Incredible India' brand-line, to promote various tourism destinations and products of the country.

Ministry of Tourism has formulated a National Strategy and Roadmap for Development of Rural Tourism in India (including agri-tourism). The strategy document focuses on the following key pillars:

- i. Model policies and best practices for rural tourism**
- ii. Digital technologies and platforms for rural tourism**
- iii. Developing clusters for rural tourism**
- iv. Marketing support for rural tourism**
- v. Capacity building of stakeholders**

vi. Governance and institutional framework

Ministry of Tourism along with Central Nodal Agency for Rural Tourism & Rural Homestays (IITTM) has launched Rural Tourism India web portal. Rural Tourism India portal has been integrated with The National Integrated Database of Hospitality Industry or NIDHI portal. Ministry of Tourism is encouraging states and stakeholders to register their destinations and experience based properties in NIDHI plus portal.

Central Nodal Agency for Rural Tourism (IITTM) under the aegis of Ministry of Tourism is implementing the Best Tourism Village Competition. The Best Tourism Village Competition seeks to honour a village that best exemplifies a rural tourism destination with the overarching goal of making tourism one of the drivers of positive change, rural development and community well being.

Ministry of Tourism has instituted a National Tourism Award in the category of 'Best Rural/Agri/Plantation Tourism projects' to motivate the stakeholders in the tourism sector for implementing such projects.

(d): The details of the tourism development projects undertaken by Ministry of Tourism under its schemes 'Swadesh Darshan', 'National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive' (PRASHAD) and Assistance to Central Agencies for Tourism Infrastructure Development are at Annexure I, II and III, respectively.
