(a) Whether the Government has initiated any plan/ scheme to promote agroforestry in the country and if so, the details thereof;

(b) the details of areas which have been identified for the said agro-forestation, State-wise;

(c) whether the Government proposes to provide any financial assistance to the farmers engaged in agro-forestry;

(d) if so, the details thereof and the assistance provided to them during each of the last three years and the current year, State-wise; and

(e) whether the Government has implemented Har Medh Par Pedh scheme/ programme to promote agro-forestry in the country and if so, the details of achievements made and financial assistance provided in this regard?

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE

(a): The Centrally Sponsored Scheme of Sub-Mission on Agroforestry (SMAF) was implemented by the Department of Agriculture & Farmers Welfare since 2016-17 to encourage tree plantation on farm land along with crops/ cropping systems to help the farmers get additional income. The scheme has now been restructured as an Agroforestry Component under Rashtriya Krishi Vikas Yojana (RKVY) and focuses on Quality Planting Material. Under the scheme, financial assistance is being provided to the beneficiaries for establishment of nurseries and raising of saplings.

(b): The SMAF was implemented in 21 States *viz* Andhra Pradesh, Bihar, Chhattisgarh, Gujarat, Haryana, Himachal Pradesh, Jharkhand, Karnataka, Kerala, Madhya Pradesh, Maharashtra, Odisha, Punjab, Rajasthan, Tamil Ndau, Telangana, Uttar Pradesh, Mizoram, Manipur, Meghalaya, Nagaland and 2 Union Territories (UTs) *viz* Jammu & Kashmir and Ladakh. The scheme was implemented in the States having liberalized transit regulations for transport of timber. The restructured Agroforestry Component is being implemented under RKVY and for the current financial year, Annual Allocation has been made to 25 States and 2 UTs as shown in Annexure I.

(c): Under the restructured Agroforestry Component of RKVY, financial assistance is being provided to farmers for establishing nurseries and raising saplings. The details of cost norms of assistance being provided is shown at Annexure-II

(d): State wise details of release of funds for promotion of agroforestry during last three years and fund allocation for the current year is shown at Annexure-I

(e): Sub-Mission on Agroforestry (SMAF) was implemented from 2016-17 to 2021-22 with the motto of "Har Medh Par Ped", to encourage tree plantation on farm land along with crops/ cropping systems to help the farmers get additional income. Under this scheme, an area of 1,61,238 Ha has been brought under plantation, 899 nos. of nurseries have been established and about 683 lakh trees have been planted. An amount of Rs. 15583.64 Lakh has been released to States/UTs during the years 2016-17 to 2021-22.
