To make recommendations for rationalization & rightsizing of ICAR to transform it into a more dynamic, lean & efficient organization.

- (c): Yes, Sir. The ICAR has prepared a "Vision-2050" document.
- **(d):** The silent feature of Vision-2050 document are as under:

To keep pace with the changing technological requirements in agriculture and dissemination of appropriate futuristic agricultural technologies, ICAR has been updating the vision and strategies of research for the holistic development of Indian Agriculture. ICAR has developed perspective plans and vision for 2050. This document provides the strategic framework for innovation-led inclusive and sustainable agricultural growth in the country. The "Vision 2050" document of ICAR is addressing future research problems and opportunities emerging for development of agriculture sector like challenges towards 2050, operating environment, new opportunities, goals and targets, way forward to 2050 and strategy and the adoption of framework to achieving the goals.

The ICAR Institutes under the Council have also prepared their vision documents which is fed into the ICAR vision. Recently, the vision for 2050 has been contemplated to operationalize the PM's vision of ease of living, eliminate poverty and doubling farmers' income. The restructuring and reforms in agricultural research system have been implemented from time to time to bring more efficiency and transparency.
