- (a) the average days of employment provided per household under the Mahatma Gandhi National Employment Guarantee Scheme (MGNREGS) during each of the last five financial years starting from 2018-19 to 2022-23;**
- (b) the average days of employment provided per household under MGNREGS in the first quarter of the current financial year; and**
- (c) the number and percentage of all job cardholding households interested in working under the MGNREGS who did not get a single day of work during the said period?**
