(a) whether the livestock sector is one of the most rapidly growing components of the rural economy of the country, if so, the details thereof; and

(b) the details of the livestock sector grew and crop farming grew in the last decades and the details in rural households that own livestock, women who are invariably engaged in animal rearing and their income also on average, State-wise since 2014 onwards?

ANSWER

THE MINISTER OF FISHERIES, ANIMAL HUSBANDRY AND DAIRYING (SHRI PARSHOTTAM RUPALA)

(a): Yes, Livestock Sector is one of the most rapidly growing components of the rural economy of the country. Livestock Sector in our country has been growing at a Compound Annual Growth Rate (CAGR) of 7.67% (at constant prices) from 2014-15 to 2021-22. The details of sector-wise Gross Value Addition (GVA) and its growth rate is given in Annexure-I.

(b): The details of Compound Annual Growth Rate (CAGR)of the Livestock and Crop farming sector during last two decades are as below-
